Equipment must be returned on time. **ANY AND ALL DAMAGE** to the equipment that is caused as a result of the lessee's operation or oversight is the sole responsibility of the lessee. Do not leave boats unattended. Lessee is responsible for being aware of tides, currents and winds. Boats are to be returned relatively clean and in the same condition as they were when you took them out. **No one under 13 is allowed to operate kayaks.**

**I hereby certify that** I will be using the kayak that I have rented, are capable swimmers, and that I am also aware that I am to wear the life vests at all times while in the kayak in accordance with California Law. I am aware that kayaking involves a risk of drowning. Additionally, I am also aware that there are natural dangers to kayaking in California, including (but not limited to) tides, currents, sunburn, bugs, snakes, sharks, sting rays, and oyster beds. I agree to hold harmless KAYAK ADVENTURE SONOMA RENTALS, it's owners, employees, and agents, from any and all liability resulting from any accident and/or injury associated with the rental described above.
