# 2. ROLL CALL – DETERMINATION OF A QUORUM

a. APPROVE DIRECTOR ABSENCES AS EXCUSED/UNEXCUSED

Directors Rourke, Eggleston, Sauer, Keys, Hickman and Brinkley were all present. Directors Miller, Dummer and Hauser Scott were absent. Director Brinkley moved to excuse Directors Dummer, Miller and Hauser Scott's absence, seconded by Director Keys and motion passed unanimously.

### 8. APPROVE SEPTEMBER 2019 FINANCIAL REPORTS

Sue Erenberger said there are few things that she needs the board to review and approve. The Accountant created a list of journal entries to clean up the 2018 financials and Sue would like the board to approve them since they had already approved the 2018 financials before.

Sue said the \$3,000 is for is for depreciation for lease holder improvements to the house and they needed to be corrected as well. Discussion ensued.

Also, in the review, our wages were higher than our W3 reported. We need to move payroll taxes from wages accounts to payroll taxes account. Discussion ensued.

Sue explained that the reason why we are reviewing and approving these changes is they directly alter financials that the board had previously approved. Discussion ensued.

Director Hickman moved to approve the changes, seconded by Director Eggleston and motion passed unanimously.

Director Rourke said he would like to see all board members receive the full financial report each month, so all directors are aware of what is going on with the fair financially. Discussion ensued.

Director Sauer moved to approve the September 2019 financials, seconded by Director Hickman and motion passed unanimously.

### **10. CEO'S REPORT**

Director Rourke explained that one of the major sources of income for the fair this year has been the RV park. Up until recently, the RV park has been full. Discussion ensued.

Director Rourke updated the board and said Ed Delisle has been served with a 60-day notice to vacate the fair house for use by the next CEO. Dennis went on to say that he and Ed had a chat about everything, and Ed understands it was a technicality, but it had to be done. Discussion ensued.

Director Rourke said he would like to see the Revenue Generation Committee look at the camping prices as we are the cheapest in the county. Discussion ensued.

- d. JR. LIVESTOCK COMMITTEE: Laura Taylor (Chairman), Wallace Brinkley Laura Taylor said JLC has a recommendation they would like to make. The recommendation is to charge \$10 per small animal exhibit slaughter charge to cover packing materials, waste fee and wear and tear to the slaughter trailer. The JLC recommends the fee to discourage abuse. In addition, JLC is also recommending a \$15 slaughter fee to the small animals that were not auctioned. Discussion ensued.

Director Rourke asked Laura Taylor if the kids will be involved in the processing of their animals. Laura replied "yes absolutely. We will not process animals without the exhibitors help". Discussion ensued. Director Brinkley moved to accept the JLC recommendations, seconded by Director Hickman and motion passed unanimously.

Laura said Jennilea Brookins will help with this year's premium book. Discussion ensued.

So far, we have found that from 7am to 11pm, the noise level should be at 60 decibels and from 11pm to 7am, it should be 45 decibels.
