## NOTICE OF PUBLIC REGULAR SESSION

### AGENDA

**1. Call to Order**

**4. Executive Session**

*A.R.S. § 38-431.03 permits an executive session or closed meeting to be held for discussion and consideration of any of seven particular subjects. A majority of the members of the Governing Board must vote to convene an executive session during a public meeting held prior to the executive session. The general public is properly excluded from such a session. Only those individuals necessary to the conduct of such a meeting may be present. All matters discussed in an executive session must be kept confidential by those attending. No vote may be taken during an executive session. Any final action on an item discussed in an executive session must be taken during a public meeting. A.R.S. § 38-431.03.*

*The purposes for which an executive session discussion may be held are the following:*

- A. Personnel matters involving a specific individual.*
- B. Confidential records.*
- C. Student discipline matters.*
- D. Legal advice provided by the public body's attorney.*
- E. Discussion of pending or contemplated litigation with the public body's attorney.*

- F. *Instruction of designated representatives concerning negotiations with employee organizations.*
- G. *International and interstate negotiations and negotiations by a city or town with a tribal council.*
- H. *Instruction of designated representatives concerning negotiations for the purchase of real property.*

**INSTRUCTIONAL METHOD:** Remote

**EXPLANATION OF METHOD:** Students will login into their assigned computer lab (learning lab) at the beginning of each scheduled period for virtual attendance via Google Meets.

**ATTENDANCE TRACKING:** Student attendance procedures will be the same as if the student were on-site and in-person. Attendance is taken at the beginning of each scheduled period (per bell schedule). Students not logged on within the first 10 minutes of each period will be counted as absent. If a student logs on after the first 10 minutes, their entry time will be logged as tardy, and a time adjustment will be entered in the SIS as if they were a late arrival.

Students marked absent may be marked present if their computer-assisted instructional program (Edmentum Courseware) logs student activity during the scheduled class period. Lastly, any time not logged by the Edmentum Courseware system may be documented by using the Weekly Student Time Log (Attestation Form) with detail regarding instructional activity logged daily and signed by both the student and parent/legal guardian.
