THIS DATE IN HISTORY

Aug 22, 1962 Kennedy administration officials quoted in the New York Times estimate that there are 20,000 guerrilla troops in South Vietnam. Despite hundreds of engagements during the preceding two months and encouraging victories for South Vietnamese forces during the first six months of the year, the Viet Cong have grown in numbers, and some U.S. officials feel that the war has become stalemated.

Aug 18-24, 1965 U.S. Marines conduct Operation Starlite on the Van Tuong Peninsula 16 miles south of Chi Lai, Quang Ngai Province, I Corps. In this the first major operation of the Vietnam War conducted only by U.S. troops, 5,500 marines from the 3rd, 4th, and 7th Marines destroy a Viet Cong stronghold, scoring a resounding victory. Ground forces, artillery from Chu Lai, naval gunfire, and air support combine to kill nearly 700 Viet Cong soldiers.

Aug 11, 1972 The last U.S. ground combat unit in South Vietnam, the 3rd Battalion, 21st Infantry, Task Force Gimlet, is deactivated, along with G Battery, 29th Field Artillery. Delta Company had completed the 3rd Battalion's last patrol on Aug 5, ending the U.S. infantry war in Vietnam.


Vice President's Corner

National Monument to Gold Star Mothers & Families

The Gold Star Mothers National Monument Foundation (GSMNMF) has gained authorization for the monument to be located on federal land, adjacent to Arlington National Cemetery. According to foundation literature, "The monument will honor all mothers and families, whether members of an organization or not, who know the grief of losing a loved one, and will promote a bond of kinship among those who memorialize our nation's defenders." The prototype of the statue under consideration for the Gold Star Mothers Family Monument resides in Carmel, N.Y. The statue concept is of a mother receiving a telegram with news of her child's death.



Harry W. Colmery Veterans Education Assistance Act of 2017

The new legislation, released by the committee last week — and supported by VA officials — includes an expansion of benefits for reservists, Purple Heart recipients and surviving dependents, as well as the elimination of a requirement that veterans use their education benefits within 15 years of active-duty service, among other provisions. July 24 the H.R. 3218 bill passed in the House on July 24, 2017 and goes to the Senate next for consideration. This bill is also known as the Forever GI Bill.

H.R. 3327, the Jack Alderson Toxic Exposure Declassification Act Rep. Mike Thompson (D-CA-5th) introduced H.R. 3327, the Jack Alderson Toxic Exposure Declassification Act. Thompson's standalone bill that would require the Department of Defense to declassify documents related to any known incident in which no less than 100 members of the Armed Forces were exposed to a toxic substance. "This bill will go a long way to benefitting veterans of all generations whose health has been impacted by exposure to toxins during their military service," said John Rowan, Vietnam Veterans of America national president.

VETERANS AID AND ATTEDNANCE BENEFIT

If you are a veteran overwhelmed with the high cost of long-term elder care, such as paying for assisted living facilities, home care aids, adult daycare, or skilled nursing, the Veterans Aid and Attendance benefit could be the solution to help offset these rising care costs. Dear Secretary Shulkin:

I write to you today to express my concerns about treatment and compensation of veterans exposed to Agent Orange. As you may know, since the 1970s, veterans have suffered from high blood pressure and strokes to be the result of their exposure to Agent Orange. The Journal of Occupational and Environmental Medicine published in November 2016 the study (Herbicide Exposure, Vietnam Service, and Hypertension Risk in Army Chemical Corps Veterans) commissioned by President Barack Obama confirms that vets exposed to Agent Orange are more likely to have high blood pressure and strokes as compared to those who weren't exposed. I write to urge you to use the Department of Veterans Affairs' existing statutory authority to quickly make high blood pressure and strokes presumptive to being exposed to Agent Orange. Center For Disease Control estimates that 115 veterans die daily because of exposure to Agent Orange. Each day delayed is more Vets dead.

When the men and women of our Armed Forces volunteer to defend our country, they do so believing that their government will do everything possible to keep them safe and healthy. They deserve access to top quality benefits and services, especially when they sacrifice their health for our nation. We have a responsibility to help these men and women live lives that are as active and productive as possible, which is why I hope you can commit to using your full authority to address this critical issue.

Thank you for your continued service to the men and women who fought to keep our nation safe and free. I look forward to your response and to working with you to improve care for our veterans in the future.
