Fire Chief's Report

In the month of March 2011, Rye Fire responded to 54 calls for service (20 fires and 34 EMS). In comparison with the same time period in the past two years, March 2011 had 6 fewer calls that 2010 and 18 fewer calls than 2009. Year to date statistics show a 9 call decrease from 2009 and a 5 call decrease from 2010.

On March 20, during Red Flag Conditions, a wildland fire was reported in the vicinity of Decker Circle. A controlled burn that had been thought to be extinguished by the land owner rekindled burning several acres of brush and grass. A similar even occurred in March of 1999.

From April 4th through the 14th, Rye Fire staff completed CPR and First Aid training for students in Mr. Hale's and Mr. Bailey's physical education classes. This is phase one of a multi-phase project to assist each of the students at the high school to graduate with CPR and First Aid training. Funding for the project has come from the Qwest Foundation, Rye Telephone, and Nick's Boots.

On April 2 and 3, Rye Fire personnel attended Emergency Vehicle Operator Training taught by Jerry Ward of VFIS, our insurance provider. The class consisted of 16 hours of classroom and practical training.

On April 3 – 5 firefighters from Rye assisted the Larimer County Sheriff with the suppression of the Crystal Fire. Engine 16, staffed by Kurt Thompson, Larry Archuleta, and Ross Marsh responded on April 3. On April 4, Larry Klock and Randy Lownes were requested to assist the incident management team. All personnel were released from the fire by April 12.

Old Business

Hatchet Ranch

Spokesperson from Hatchet ranch had some updated information.

Petitions have been mailed out. Roughly 62% of the land owners that live in Hatchet Ranch have responded yes. Some petitions may not be complete; these are in the correction process.

Estimated amount that will be received for inclusion fee is \$56,000. Also have bee working on location for cisterns, a total of 4 locations.

Through this process a list of 11 people that are interested in volunteering for the Fire District was obtained.

Next step would be an open public meeting. This will be listed as a public notice and we will have the Public Hearing and the next regular meeting.
