Note: Your display, including any vehicles/trailers used in your display, must fit within the space size you select - no overages allowed. If in doubt, select the next size up.

Food truck vendors must select 30ft (W) x 15ft (D) – NO EXCEPTIONS.

- 15ft (W) x 15ft (D) standard booth **included** with Food & Beverage
- 30ft (W) x 15ft (D) oversized booth (beyond standard 15' x 15' booth) - **ADD \$50** to total
- 15ft (W) x 30ft (D) oversized booth (beyond standard 15' x 15' booth) - **ADD \$25** to total

Health Permit Info: As a food and/or beverage vendor you must have a health permit issued by the County of Sacramento. Permits will be checked & validated by the Sacramento County Health Department during the course of their health inspections at the event. If you exhibit and do not have a valid permit, you will be charged a fine as established by the Sacramento County Health Department – all fines assessed, will be payable upon inspection of your booth and before you will be allowed to exhibit.
