If you are mailing after May 1st please include the late fee or you won't be able to pick up your membership cards or be allowed into the pool until that is paid.

Don't forget to purchase your guest passes in advance to get the \$7 discounted rate. Guest passes are good for (2) seasons.

MEMBERSHIP CARDS

All memberships <u>MUST</u> be 100% paid in full prior to receiving pool cards and admittance into the pool and pool grounds. Under <u>NO</u> circumstances will <u>ANY</u> family member be admitted into the pool under a membership that has payment outstanding including late fees. Please do not drop off your teens or other family members with a membership that is not valid. There will be <u>NO</u> exceptions to this rule. Also please remember to always have your membership cards, as <u>NO</u> members will be allowed into the pool without them.

IMPORTANT NOTICE FOR STOCKHOLDERS:

Please remember the inactive membership policy: According to our bylaws, "There shall be a \$50.00 Inactive Membership fee assessed to any member that does not become active during each season. All members shall be notified of such an assessment each year in the Splash and dues notices. Should unpaid fees meet or exceed the par value of the stock, the members stock shall be recalled." This means that after 4 years of inactivity your stock value will be \$0. Please don't let your stock value depreciate!

There will be (6) 1-week sessions. 30 minute classes with time slots in the mornings and evenings.


