The 2015 SmileFaith "Smile Makeover" program provided \$510,000 worth of charitable dental services and counseling resources to disadvantage residents in Florida. The 2015 SmileFaith "Dentistry That Cares" program provided \$141,500 worth of charitable dental services through special community events and partnerships. And the 2015 SmileFaith "Mountain Mobile Dental Bus" project provided \$447,200 worth of charitable dental services and life resources to the residents of rural Eastern Kentucky.
