Canada & PESC

The Canadian Presence and Influence within PESC has Existed since the very Formation of PESC. As Canadian students cross provincial and international borders to attain their education, the need for institutions, software providers and systems vendors that support Canadian and international markets to ensure mobility and interoperability has never been greater.

The formation of the Canadian PESC User Group (CanPESC) in 2011 solidified the importance of Canada's role within PESC and drew together many Canadians from across the country to work towards a common goal. Its main mission is twofold:

- To encourage participation in PESC XML workgroups developing PESC Approved Standards
- To promote and educate Canadian stakeholders on the importance of data standards and interoperability, thereby avoiding duplication of efforts, costs and of data standards.

As the voice and official committee representing Canadian interests, CanPESC also serves in a liaison role. It coordinates and communicates its efforts across all provinces and territories, and works closely with Canadian organizations such as the Association of Registrars of Universities and Colleges of Canada (ARUCC).

The Canadian Influence and History within PESC

- In PESC's 1st Annual Best Practices Competition in 1999, the Ontario Universities' Application Centre (OUAC) won 1st PLACE for its submission, "Ontario Universities' Electronic Transcript System (OUETS): A Model of an Electronic Standardization Initiative."
- In PESC's 14th Annual Best Practices Competition in 2012, the Ontario College Application Service (OCAS) won 1st PLACE for its submission, "OCAS XML Transcript Initiative."
- For PESC's 10th Year Anniversary, the PESC Fall 2007 Data Summit was held at the Ritz-Carlton Hotel in Montreal.
- At the PESC Fall 2011 Data Summit held October 26, 2011 in San Francisco, PESC launched the Canadian PESC User Group.
- For PESC's 15th Anniversary Year, the PESC Fall 2012 Data Summit was held at the Four Seasons Hotel in Vancouver.
- Through establishment of CanPESC, PESC entered into a formal MOU with ARUCC in 2013, allowing ARUCC and PESC to attend each other's events without charge, thereby fostering a closer working relationship.
- OUAC staff have been recognized with PESC's Distinguished Service Award: Doug Holmes in 2013 and Leisa Wellsman in 2016.
- OCAS' William McKee served on the PESC Board of Directors from 2013-2015.

CHAIRED BY KATHLEEN, THE PURPOSE OF THE TASK FORCE WAS TO EXPLORE AND GARNER SUPPORT FOR A NATIONAL MOBILITY NETWORK, CONNECTING CANADIAN PROVINCES TO EACH OTHER AND ULTIMATELY THE REST OF THE WORLD. THIS SESSION WILL EXPLORE THE EVOLUTION OF A NATIONAL POSTSECONDARY STUDENT MOBILITY DATA-SHARING CULTURE AND NETWORK IN CANADA.

THE GRONINGEN DECLARATION NETWORK, NOW A FORMAL AND LEGALLY ESTABLISHED ORGANIZATION, AIMS TO ADVANCE MOBILITY, TO FOSTER DEVELOPMENT OF BEST PRACTICES AND GLOBALLY ACCEPTED STANDARDS FOR THE SECURE, CITIZEN CENTERED CONSULTATION OF EDUCATIONAL DATA ALLOWING GLOBALLY MOBILE CITIZENS TO SHARE THEIR AUTHENTIC EDUCATIONAL DATA WITH WHOMEVER THEY WANT, WHENEVER THEY WANT, WHEREVER.

ORIGINALLY SIGNED ON APRIL 16, 2012 AT THE CLOSURE OF THE GLOBAL FOUNDING SEMINAR: DIGITAL STUDENT DATA DEPOSITORIES WORLDWIDE IN THE NETHERLANDS, THIS INAUGURAL CONVENING WAS BROADENED IN 2013 WITH A MEETING IN BEIJING; IN 2014 AT GEORGETOWN UNIVERSITY IN WASHINGTON, D.C.; IN 2015 AT THE UNIVERSITY OF MÁLAGA IN SPAIN; IN 2016 IN CAPE TOWN, SOUTH AFRICA; AND IN 2017 AT THE UNIVERSITY OF MELBOURNE, AUSTRALIA.

HERMAN DE LEEUW, EXECUTIVE DIRECTOR, FIRST ADDRESSED THE PESC COMMUNITY AT THE FALL 2015 DATA SUMMIT AS KEYNOTE SPEAKER, FOLLOWING PESC'S JOINING THE GRONINGEN DECLARATION NETWORK AS SIGNATORY. IN TWO YEARS SINCE, THE NUMBER OF SIGNATORIES HAS VASTLY EXPANDED, THE MISSION IS RESONATING AROUND THE WORLD, AND PLANS ARE BEING MADE FOR THE NEXT ANNUAL MEETING FOR 2018 IN PARIS. THESE TOPICS, PLUS A PERSPECTIVE ON STUDENT MOBILITY, CREDENTIALS, AND THE IMPORTANT ROLE OF COLLABORATION WILL ALL BE DISCUSSED.

THE BLOCKCHAIN REVOLUTION HAS RECENTLY COME TO THE EDUCATION SECTOR WITH THE PROMISE OF PROVIDING A TAMPER-PROOF INFRASTRUCTURE TO FACILITATE STUDENT OWNERSHIP AND USE OF ACADEMIC RECORDS. THIS MEANS STUDENTS CAN SHARE THEIR OFFICIAL RECORDS DIRECTLY WITH ANYONE AND HAVE THEM EASILY VERIFIED AS AUTHENTIC. THESE RECORDS NO LONGER HAVE TO BE TRANSMITTED BY A THIRD PARTY, WHICH IS A FUNDAMENTAL BREAK FROM THE TYPICAL VENDOR-CONTROLLED ECOSYSTEMS WHERE RENTS MUST BE PAID TO USE OR TRANSMIT OFFICIAL RECORDS. IN THIS SESSION, ATTENDEES WILL BE INTRODUCED TO BLOCKCHAIN, ITS HISTORY AND APPLICATIONS, AND HOW TRUST, NON-REPUDICATION AND MOBILITY ARE ADDRESSED.

ACADEMIC CREDENTIALING ITSELF IS EXPERIENCING AN OVERALL ENTERPRISE-WIDE RE-ENGINEERING. WHILE STUDENT MOBILITY CONTINUES TO DRIVE MANY TECHNOLOGIES AND APPLICATIONS, ENSURING PRIVACY, SECURITY, AUTHENTICITY AND UNDERLYING TRUST REMAIN A CHALLENGE. MANY INSTITUTIONS ARE EXPERIMENTING WITH EMERGING TECHNOLOGIES AND APPLICATIONS AND COLLABORATING WITH LABOR AND WORKFORCE SECTORS. IN THIS SESSION, ATTENDEES WILL LEARN ABOUT NUMBEROUS GROUPS AND INITIATIVES INVOLVED WITH UMUC AND WITH PESC'S ACADEMIC CREDENTIALING & EXPERIENTIAL LEARNING TASK FORCE, OF WHICH JOELLEN IS CO-CHAIR, (AACRAO, C-BEN, CAEL, CREDENTIAL MAPPING, AMONG MANY OTHERS), THEIR GOALS AND MISSIONS AND HOW TO GET INVOLVED.

DIPLOMA SUPPLEMENT RECENTLY THE EUROPEAN UNION (EU) RELEASED ITS FINAL REPORT ON THE *DIGITALISATION OF THE DIPLOMA SUPPLEMENT*. THE DIPLOMA SUPPLEMENT, DEFINED BY THE EU, *IS A DOCUMENT ACCOMPANYING A HIGHER EDUCATION DIPLOMA, PROVIDING A STANDARDISED DESCRIPTION OF THE NATURE, LEVEL, CONTEXT, CONTENT AND STATUS OF THE STUDIES COMPLETED BY ITS HOLDER*. IT IS PRODUCED BY THE HIGHER EDUCATION INSTITUTIONS ACCORDING TO STANDARDS AGREED BY THE EUROPEAN COMMISSION, THE COUNCIL OF EUROPE AND UNESCO. WITH THE NEED FOR A NEW DIGITAL DOCUMENT, THIS SESSION WILL DISCUSS THE IMPACT OF THE DIPLOMA SUPPLEMENT, ITS TIMELINE, AND WHAT ROLE PESC MIGHT PLAY IN STANDARDS DEVELOPMENT.

EDEXCHANGE: PESC'S NEUTRAL DIGITAL LOOK-UP AND DATA TRANSPORT SERVICE EDEXCHANGE IS A DATA EXCHANGE SERVICE OFFERED AND OPERATED BY PESC AND DIRECTLY MANAGED BY PESC MEMBERS. THE FOUNDATION OF THE SERVICE IS A DIRECTORY 'LOOK UP' SERVER THAT LISTS INSTITUTIONS, SERVICE PROVIDERS AND OTHERS THAT ARE ABLE TO EXCHANGE DATA ELECTRONICALLY. THE SERVER ITEMIZES THE TECHNICAL CAPACITY OF EACH, WHICH DOCUMENT TYPES ARE SUPPORTED ELECTRONICALLY AND ADDITIONAL IDENTIFIER DATA. TO EXCHANGE DATA, USERS THEN CONNECT DIRECTLY WITH THE RESPECTIVE RECIPIENT. ACHIEVED THROUGH AN OPEN WEB SERVICES ARCHITECCTURE AND ASSOCIATED STANDARDS, EDEXCHANGE IS DESIGNED AS A PEER-TO-PEER NETWORK PROVIDING A SECURE, RELIABLE AND DIRECT CONNECTION BETWEEN USERS AVOIDING FILE-BASED TECHNOLOGIES. THIS SESSION WILL INTRODUCE ATTENDEES TO EDEXCHANGE, REVIEW CURRENT EDEXCHANGE PILOTS, AND DISCUSS NEXT STEPS.

PESC GEO CODE: A TRUSTED DIGITAL CODE FOR INSTITUTIONS AND EDUCATION ORGANIZATIONS GEO CODE IS A 'LOOK-UP' SERVICE OFFERED AND OPERATED BY PESC AND DIRECTLY MANAGED BY PESC MEMBERS. THE FOUNDATION OF THE SERVICE IS A DIRECTORY 'LOOK UP' SERVER THAT LISTS ACTIVE AND INACTIVE INSTITUTIONS, INCLUDING HISTORICAL DATA PLUS ADDITIONAL DEMOGRAPHIC AND IDENTIFIER DATA. COUNTRIES CURRENTLY LISTED: ANTARCTICA, ARGENTINA, AUSTRALIA, CANADA, BRAZIL, CHINA, FRANCE, INDIA, NEW ZEALAND, PEOPLES' REPUBLIC OF CHINA, PROVINCE OF TAIWAN, POLAND, UNITED KINGDOM AND THE UNITED STATES OF AMERICA. THIS SESSION WILL DISCUSS THE VALUE OF A TRUSTED CODE, THE CURRENT USC PILOT, NEXT STEPS IN THE DEVELOPMENT OF SUPPORTING TECHNOLOGY, AND HOW TO PARTICPATE.

Policies & Logistics

REGISTRATION

PESC requires that all speakers, moderators, chairs and attendees of Data Symposiums & Summits register and remit payment to attend Data Symposiums & Summits. PESC and attendees are thankful to all speakers and grateful for their efforts in volunteering to provide updates and presentations. Only in rare instances, however (that is if a speaker is only attending a Data Symposium & Summit for a specific session or presentation), can registration fees be waived and only by the PESC office.

SUMMIT OVERVIEW

All General and Breakout Summit Sessions and events are open to all registered attendees. Dress code is business casual. Transparent collaboration, engaging discussions, awareness of technical resources and best practices, identification of emerging technologies, new business contacts, and tips from experts of leading community organizations can be expected.

Note that General Sessions are presented in typical conference format in which featured speakers or panelists present (consecutively) on a certain topic followed by brief Q&A; while Breakout Sessions follow a more informal workshop format (concurrently) in which group members roll up their sleeves, discuss and interact in more detail in order to advance the group activities and maximize in-person convening time.

GENERAL SESSION PRESENTATIONS

For MODERATORS, the role is to open the session, welcome attendees, introduce the topic and the speakers, ensure room logistics (volume, sound, temperature), facilitate Q & A, and ensure that sessions start and end on time.

For SPEAKERS, all hardware and software is ready and set up (laptop, projector, screen, podium, microphone, etc.). If speakers have a specific presentation, they can simply bring it with them on USB and plug it in right before the scheduled presentation. PESC can also swap in/out laptops if needed. Note that Powerpoint Presentations are NOT required.

TIPS For PRESENTATIONS: Remember to communicate the basic information and speak directly into the microphone: what is the name of the topic, who owns or administers it, how is it funded, what's it status and when is it effective, who is it for (students?), what are the next steps? Fonts used in Powerpoint should be large (18+). PESC can also coordinate printing and distribution of handouts if submitted one week prior to the Summit. Lastly, there is no template slide to use for presentations. Please use your own logos and your creative energy to capture the attention and imagination of the PESC attendees.

BREAKOUT SESSIONS

For BREAKOUT SESSIONS, each room, if needed, is equipped with projector, screen and speaker phone and may be setup in U-Shape format. Group Chairs are responsible for managing and facilitating all sessions and preparing and distributing respective agendas and information.

CANCELLATION POLICY

Cancellation and refund requests must be made in writing (e.g. email) and will be processed 30 days after the FALL 2017 DATA SUMMIT concludes. Any person who registers and decides not to attend MUST send a formal cancellation request - otherwise payment is due. Requests made by September 1, 2017 may be considered for a refund upon request. Any request made after September 1, 2017 is not eligible for a refund regardless of the attendance of the registrant. Refund and/or cancellation requests must be submitted to the PESC Office.

Together EWP has taken a bottom-up approach to influence the HEIs to exchange student information for mobility programmes fully in an electronic way by providing an evidence-based feasibility study with different use case scenarios and the practical solution to build connect all existing systems in one network.

The EWP network is the first attempt to standardize student data transfer on a European-wide scale. It is important to note that the transfer does not involve documents themselves (e.g. scanned copies) but the data themselves that are contained in these documents, so that they can be used for the generation of various documents.

Interoperability is a property referring to the ability of diverse products, systems and/or organizations to work together (inter-operate).

The term is often used in a technical <u>systems engineering</u> sense, or alternatively in a broad sense, taking into account social, political, and organizational factors that impact system to system <u>performance</u>.

For systems interoperability specifically, organizations communicate through <u>interfaces</u> which are completely understood...each can work with the other's products or systems <u>without any</u> restricted access or implementation.





PESC & Academic Credentialing

In June 2015 at its Annual Retreat, the PESC Board of Directors, due to the impact of student mobility on the international credentialing landscape, authorized the formation of the Academic Credentialing and Experiential Learning Task Force.

This Task Force formed and convened for its inaugural meeting at PESC's Fall 2015 Data Summit in Washington, D.C. With Tom Black, Associate Vice Provost for Student Affairs & University Registrar at Stanford University, as Task Force Chair, and Co-Chairs Joellen Shendy, Associate Vice Provost and Registrar at the University of Maryland University College and Alex Jackl, CEO and Founder of Bardic Systems, the Task Force committed to monitoring and tracking current initiatives, providing speakers and presenters at several industry-leading conferences and events, serving as a clearinghouse for information, and ensuring PESC is prepared for standards development work as the community is reaching the point in which standards are needed.

Through analysis and discussion, Chair Tom Black identified an associated gap in the North American market whereby no standards existed for the exchange of certificates, degrees and diplomas. Work began immediately to shape a standard and evolved into the *PESC Approved XML Common Credential for Certificates, Degrees and Diplomas.* The Task Force continues to convene and focus on new and specific use cases (business or process cases) to determine their value and need in the community while leveraging technology and standards to meet the needs of emerging mobile academic credentials.

In June 2016 at its next Annual Retreat, the PESC Board of Directors discussed the numerous industry groups and initiatives focusing on credentials. In-depth discussions lead to the realization that a significant part of community needs are not be addressed in that no organization is showcasing how to work with all the different groups and initiatives, and more importantly how the different groups and initiatives all relate to one another.

With that in mind, the PESC Board of Directors subsequently authorized the dedication of PESC's Spring 2017 Data Summit to this one theme and purpose – *Empowering the Mobility of Digital Academic Credentials*. As PESC is a sponsor of Connecting Credentials, leaders at Connecting Credentials correspondingly co-sponsored the Spring 2017 Data Summit.

In the spirit of interoperability, leaders of Credential Engine proposed a comprehensive data mapping initiative across Credential Engine, PESC, HR-Open Standards, and IMS in order to advance interoperability; and with immediate agreement by all, organizational meetings began in April 2017. As part of this initiative, PESC and HR-Open Standards signed a joint MOU in August 2017.

PESC is corresponding Partners with Erasmus Without Paper and EMREX, and is undertaking additional data mapping exercises including data transmission and exchange.







DISTINGUISHED SERVICE AWARDS
