Annual Fund Drive

A Trust Fund has been established under the control of the Foundation Board. 75% of the contributions received through an Annual Fund Drive go toward the School Operating Fund. These funds may be used for school operations subject to the Education Foundation Board approval. The remaining 25% are invested in the Reserve Fund for future capital improvements or needs. All funds are placed with Central Trust Company in a Fiduciary Investment Account.
