- 2. Fire department. Runs for month: 33: 24 june 2021 to 2020. Fire calls:4, 2 Mutual aid. EMS: 23, 6 mutual aid received 5.Open burns 2 service calls. Total runs to date 2021:194 vs, 177 2020. Fiscal officer asked if EMS broken out from Fire, since revenue for Medical has not changed at same rate. Jeffrey said he hasn't seen any denial, discussed breakout of EMS calls to identify if medical increases so should revenue. UH medial Dr. John Hill 4th new EMS director. EMS coordinator Ray ace retires, instructor only now.
- 3. Zoning Department: No report. Trustees Discussed zoning followup of a building questioned regarding setting out in front of home and close to road, ? agriculture building, no Zoning permits noted.
- 4. Fiscal Officer: Reviewed past questions about road department buying pipe for resident drives, but they said that was just an error. Residents are required to buy the pipe (or reimburse township) and additional cost is for road department work. Needed approval for ie for stroup road, clarification for road monies as price is over \$500.00.
