**§1. LEGISLATIVE INTENT:**

The Town of Cohocton has established the fourth Tuesday of May of each year as the date upon which the Board of Assessment Review shall hear complaints concerning real property tax assessment within its jurisdiction. A date other than the fourth Tuesday of May may be established by the passage of a local law as provided in the Real Property Tax Law of the State of New York.

**§2. GRIEVANCE DAY**

Commencing with calendar year 1995, the fourth Thursday of May of each year is established as the date upon which the Board of Assessment Review shall hear any complaints relative to real property tax assessment within its jurisdiction.

**§3. EFFECTIVE DATE**

This local law shall take effect upon filing with the Secretary of State.
