Changing of Guard in Local Congressional Staff

Rep. Matsui's letter disclosing Nathan's departure also announces that after working on legislative issues in her Capitol office for the past five years, Sacramento native Sam Stefanki will take over as District Director.

Born and raised in Yuba City, Andrew is looking forward to working on Delta and flood protection issues.

Delta Levee Investment Decision-Support Tool to Be Unveiled at Public Workshop

The Delta Stewardship Council has scheduled a public meeting on the morning of Monday, October 12th (see above) to have the consultants developing the methodology and Planning Tool for the Delta Levee Investment Strategy (DLIS) to demonstrate the draft decision-support modeling tool. DSC staff will also discuss the next steps including the use of conceptual investments to reduce risk and their cost-effectiveness.

CCVFCA members and staff, and other Delta stakeholders interested in flood protection have expressed concern with the methodology and guiding Principles developed thus far. The Association has pointed out that the Delta Levees Program (Subventions and Special Projects) is one of two successes in the Delta over the last three decades and therefore questioned the need to replace it with an untested new tool that an Independent Science Panel review warned is not scientifically sound.

According to the current <u>schedule for DLIS</u>, the Council plans to complete a Draft EIR and release a Final Draft Strategy in December with the intent to adopt DLIS as an enforceable regulatory policy in the Delta Plan at their June 2016 meeting.

WSAFCA Newest Member of CCVFCA

The Association is pleased to welcome the West Sacramento Flood Control Association (WSAFCA) as its newest member. Formed in 1994 through the adoption of a joint exercise of powers agreement between the City of West Sacramento and RDs 537 and 900, WSAFCA is working with state and federal partners to design and build flood risk reduction facilities to protect more than 47,000 people and over 13,000 acres of property valued at over \$4.2 billion.
