REMOTE CONTINGENT BENEFICIARIES

Your main estate plan or state law will control if no beneficiaries remain able or willing to accept your bequest.

VALIDITY OF YOUR TRUST (REQUIRED SCHEDULES)

We provide certain Schedules for your Trust. Referenced Schedules are required to avoid having your trust returned by BATFE as incomplete.

Schedule C identifies remainder beneficiaries (#3 above). You cannot be the sole trust beneficiary. If you do not have an estate plan such as a will, please fill this out in order for your beneficiaries to be ascertainable by the BATFE otherwise the BATFE will return your trust.

Your trust must also be "funded" i.e. own assets to be valid. This can be, for example, one U.S. Dollar. This does not have to be attached to your trust.

Transfers of **NFA firearms** require a BATFE approved transfer in order for legal title to vest in the trust, but your trust can own the right to receive an approved NFA firearm at the time you pay your gun seller, or to collect a refund. That is why Schedule A should list pending NFA firearms! If you already own NFA firearms and would like to place them in the trust, you must pay the \$200 tax stamp for the transfer again.
