# Mrs. Kipp

• The owner reported that she does not believe that her car was creating an oil leak on the street and did not appreciate the letter sent to her. Mr. Konovalov reported that a general letter should also go out in the future to further address this problem at other locations.

#### Mrs. Pecarro

- The owner thanked the Board for leaving the assessment at the same rate this year.
- There is an oil leak on the street in front of her home. The leak is from other people parking in front of the home, not anyone from her family.

#### Mrs. Clement

- The owner recommended that a street sweeping company not be hired. This would be since it would save money and is not really necessary. She indicated a letter should go out and ask all phase 2 owners to sweep the gutter area in front of their own homes.
- The landscape area in the cul-de-sac street has not been addressed since the City of Anaheim cut some of it out. Mr. Konovalov will look into this matter.
- A recommendation was made to inspect the wrought iron fencing to identify areas that need attention. The Board discussed this item and will send out a request for all owners to inspect and repair their fences. The Association will inspect this in the future too.
