

**SHARED SERVICES AGREEMENT**

**THIS AGREEMENT** made this *12th* day of *MAY*, 2010

**BETWEEN: TOWNSHIP OF JACKSON**, a municipal corporation of the State of New Jersey, having its principal offices located at Municipal Building, 95 W. Veterans Highway, Jackson, NJ 08527, hereinafter referred to as "Township,"

**AND: THE JACKSON TOWNSHIP BOARDS OF FIRE COMMISSIONERS;**

**District 1:** located at 81 South Hope Chapel Road, Jackson, NJ 08527;

**District 2:** located at 785 Miller Ave., Jackson, NJ 08527;

**District 3:** located at 200 Kierych Memorial Dr., Jackson, NJ 08527; and

**District 4:** located at 465 No. County Line Road #A, Jackson, NJ 08527-4428, hereinafter collectively referred to as "Fire Commissioners,"

**WHEREAS**, Township and Fire Commissioners each have governmental authority over the same geographic area; and

**WHEREAS**, there exists within the aforesaid geographical area a need for enforcement of certain parking ordinances, and such enforcement would benefit each party; and

**WHEREAS**, the parties are desirous of reaching an agreement for such enforcement, which agreement would be mutually beneficial;

*NOW, THEREFORE*, in consideration of the promises exchanged herein,  
it is agreed as follows:

1. Fire Commissioners will, at their sole expense, continue the employment of the employees who were previously hired for the purpose of enforcing the Uniform Fire Safety Act, and Chapter 61 of the Code of the Township of Jackson, relative to fire zones and fire lanes, ordinances concerning parking in fire lanes, and fire zones, and ordinances concerning handicapped parking within the Township of Jackson.

2. Summonses issued pursuant to this agreement shall be returnable in the Jackson Township Municipal Court.

3. Fines collected from the summonses issued by the aforesaid employees of the affected Fire Prevention Bureaus shall be divided as follows:

A. For violations of the Uniform Fire Safety Act for which summonses are issued, the affected Fire Prevention Bureau shall receive 100% of the fines.

B. For violations of fire lane and fire zone ordinances, the affected Fire Prevention Bureau shall receive 100% of the fines.

C. For violations of handicapped parking ordinances, the Township shall receive 100%.


D. For any Court costs assessed, they shall be paid in full to the Jackson Township Municipal Court.

4. Money due to the respective Fire Prevention Bureaus in accordance herewith shall be disbursed by the Jackson Township Municipal Court Clerk or Treasurer, Township of Jackson on a monthly basis.


5. Fines collected from summonses issued by other Township officials and law enforcement officers shall not be affected by this Agreement, and shall belong to the Township.

6. This Agreement shall be effective upon signing, and shall be for a five year period commencing 12 MAY, 2010 and shall terminate 12 MAY, 2015.






