## General Information

- **The age of the rider is determined as of January 1, 2017.**
- **The horse's birth date shall be January 1 of the year foaled.**
- There will be awards for the high-point champion in the 8 & under 9-12, 13-17 and 18 & Over age groups. Classes that count toward high point awards are Showmanship at Halter, Costume, Bareback Equitation, Western Pleasure, Western Equitation, Reining, Trail, English Pleasure and English Equitation. All high point awards will be calculated on a one horse / one rider basis.
- Awards will be given in all classes to fifth place. Awards will be Jackpot with 50% payback.
- No horse may compete against itself, nor may any rider compete against himself/herself in the same age group or event except that exhibitors may enter more than one horse in Reining and Trail.
- AHSA rules apply (not an approved show). However, CK ground rules will prevail.
- No horses will be allowed in the cook shack area. No horses are to be tied to trees, fences, bleachers, or inside the main holding pen area. No loose foals are allowed on the CK grounds.
- Stallions must be handled by an adult, 18 years of age or older.
- Do not lope or run horses behind grandstands or near the clubhouse.
- No riding will be allowed on the Northeast hillside beyond CK fenced area. This is private property.
- Campers are welcome, however there are no hookups or drinking water. River water is available for stock.
- CK saddle club reserves the right to combine or split classes depending upon the number of entries.
- Chaps are optional in all western performance events. In western classes, exhibitors must wear boots, pants, long-sleeved shirts and western hat or helmet. In English classes, exhibitors must wear breeches, coat, English boots, derby or hunting cap or helmet.
- Junior horses may be ridden two-handed in an acceptable snaffle bit or hackamore or one-handed in a curb bit, half-breed or spade bit. Junior horses are 5 years and younger. Senior horses must be ridden one-handed in a curb bit, half-breed or spade bit. Senior horses are 6 years and older. Horses must be shown in acceptable English equipment in all English classes and in acceptable western equipment in all western classes.
- All equipment and/or attire is subject to examination by the judge.
- If the judge rules a horse uncontrollable, the horse will be disqualified and must exit the arena.
- **Please bring and ride only healthy horses. We recommend all horses be vaccinated for influenza and rhinopneumonitis.**
- **Cayuse Kids reserves the right to disqualify any contestant who displays poor sportsmanship or is abusive toward any individual or animal. You will be asked to leave.**

### **CLASS SCHEDULE**

#### **Showmanship**

- #1 ✓ **Showmanship at Halter (8 & Under)** To be judged Danish. Pattern will be posted the day of the show.
- #2 ✓ **Showmanship at Halter (9-12).**
- #3 ✓ **Showmanship at Halter (13-17)**
- #4 ✓ **Showmanship at Halter (18 & Over)**
- #5 **Leadline, 5 & Under.** To be judged Danish. To be led by a responsible handler, shown at the walk only both directions of the ring. May be required to back in line at the judge's discretion. May only cross enter with Showmanship 8 & under and Costume 17 & Under.
- #6 ✓ **Costume, 18 & Over-** Exhibitors 18 and over under to work at a walk and jog both directions of the ring, line up, stand quietly and back.
- #7 ✓ **Costume, 17 & Under-** Exhibitors 17 & under to work at a walk and jog both directions of the ring, line up, stand quietly and back.

#### **20 minute break to warm up horses**

- #8 **Walk/Jog Pleasure.** For horses 4 and younger. Rules same as class #9
- #9 ✓ **Western Pleasure, 8 & Under.** To be worked at a walk and jog both directions of the ring on a reasonably loose rein without undue restraint. Horses are required to back easily and stand quietly. Severe penalties will be assessed if 1) the horse's head is carried such that the point of the ear is lower than the withers; 2) the horse's head is flexed behind the vertical; 3) the horse is excessively slow at any gait; 4) light contact with a reasonably loose rein is not maintained; or 5) the horse appears sullen, dull, lethargic or emaciated.
- #10 ✓ **Bareback Equitation, 9-12.** To be worked at a walk, jog, and lope both directions of the ring on a reasonably loose rein without undue restraint. Exhibitors may be asked to extend normal gaits, back the horse, work individually, or perform other tests as the judge deems necessary. Pattern may be required and will be posted the day of the show. Exhibitors shall not be required to dismount and mount
- #11 ✓ **Bareback Equitation, 13-17.** Rules same as class #10
- #12 ✓ **Bareback Equitation, 18 & Over.** Rules same as class #10
- #13 ✓ **Novice Western Equitation.** Open to all ages. Rider must not have placed in the top five in any equitation class *in the past 5 years*. To be worked at a walk, jog, and lope both directions of the ring on a reasonably loose rein without undue restraint. Exhibitors may be asked to back the horse, work individually, or perform other tests the judge deems necessary.
- #14 ✓ **Walk-Trot Equitation, 8 & Under.** To be judged Danish. To be shown at the walk and the jog (trot) both directions of the ring. May be required to back in line at the judge's discretion. May only cross-enter 8 & Under Trail, 17 & Under Costume and 8 & Under Showmanship. No pattern work required. Exhibitors may wear western or English attire.
- #15 ✓ **Western Pleasure, 9-12.** Rules same as class #9 with the exception being that a lope will be required in both directions.
- #16 ✓ **Western Pleasure, 13-17.** Rules same as class #9 with the exception being that a lope will be required in both directions.
- #17 ✓ **Western Pleasure, 18 & Over.** Rules same as class #9 with the exception being that a lope will be required in both directions.
- #18 ✓ **Western Equitation, 9-12.** To be worked at a walk, jog, and lope both directions of the ring on a reasonably loose rein without undue restraint. Exhibitors may be asked to extend normal gaits, back the horse, work individually, or perform

other tests as the judge deems necessary. Pattern may be required and will be posted the day of the show. Exhibitors shall not be required to dismount and mount

#19 ✓ **Western Equitation, 13-17.** Rules same as class #18.

#20 ✓ **Western Equitation, 18 & Over.** Rules same as class #18

#21 ✓ **Free Style Reining 17 and Under.** Participants will create their own reining pattern to include small slow circles, large fast circles, lead changes, roll backs, sliding stops and spins in each direction to music. Costumes are optional. Rider must provide their own music in the form of cd or another device that can be played through the announcers microphone. Call Justin Minden with questions. Music must be turned into the announcers stand prior to lunch break. There is a time limit of 4 minutes per performance.

#22 ✓ **Free Style Reining 18 and Over.** Rules same as class 21.

15 minute break for change



#23 ✓ **English Pleasure, 17 & Under.** To be worked at a walk, trot and canter both directions of the ring. Light contact with the horse's mouth is recommended. Exhibitors may be asked to extend normal gaits, hand gallop, halt and stand quietly on a free rein and/or back. Horses will be severely penalized for 1) moving in an artificial frame or 2) being over flexed and behind the bit. Judge will emphasize free movement and manners. Quick, short strides and excessive speed will be penalized.

#24 ✓ **English Pleasure, 18 & Over.** Rules same as #23.

#25 ✓ **English Equitation, 17 & Under.** To be worked at a walk, trot and canter both directions of the ring. Light contact with the horse's mouth is recommended. Exhibitors may be asked to extend normal gaits, back the horse, work individually or perform other tests the judge deems necessary. Pattern may be required and will be posted the day of the show. Exhibitors shall not be required to dismount and mount.

#26 ✓ **English Equitation, 18 & Over.** Rules the same as class 25

**Held outside the arena from 10:00 am – 2:00 pm ONLY. Exhibitor is responsible for completing the class in the allotted time.**

#27 ✓ **Trail, 8 & Under.** Pattern will be posted the day of the show.

#28 ✓ **Trail, 9 - 12.** Rules same as class #33.

#29 ✓ **Trail, 13 - 17.** Rules same as class #33.

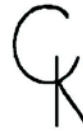
#30 ✓ **Trail, 18 & Over.** Rules same as class #33

## RELEASE, ASSUMPTION OF RISK, WAIVER & INDEMNIFICATION

WITNESS THIS AGREEMENT this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between Cayuse Kids (CK) Saddle Club, hereinafter referred to as ORGANIZER and \_\_\_\_\_ hereinafter referred to as RIDER.

Rider, Rider's heirs, assigns, and representatives, hereby agree as follows:

1. RIDER AGREES TO ASSUME ANY AND ALL RISKS INVOLVED IN OR ARISING FROM RIDER'S VOLUNTARY PARTICIPATION IN ANY ACTIVITY CONDUCTED BY THE ORGANIZER, INCLUDING, BUT NOT LIMITED TO RISKS OF DEATH, BODILY INJURY, PROPERTY DAMAGE, FALLS, KICKS, BITES, BOLTS, COLLISIONS WITH VEHICLES, OTHER HORSES OR STATIONARY OBJECTS, FIRE, EXPLOSION, LIMITED EMERGENCY MEDICAL CARE AVAILABILITY, OR THE NEGLIGENCE OR DELIBERATE ACT OF ANY OTHER PERSON. Rider acknowledges that equines, by their very nature are unpredictable and subject to animal whim. Rider assumes all risks in connection therewith, and expressly waives any claims for any injury or loss arising there from. Rider agrees to abide by and follow Organizer's rules and regulations. Rider further acknowledges that the behavior of any animal is contingent to some extent upon the ability of Rider. Rider assumes all risks therefore and warrants that Rider has the requisite abilities to safely participate in the Activity.

WARNING - All Activities involving HORSES, donkey, mules or ponies (equines) have inherent risks for Participants/Riders. Idaho State Law protects operators, owners, trainers, promoters and others from liability for injuries which are the result of an equine animals' behavior. RIDE AT YOUR OWN RISK.

2. Rider agrees to hold harmless, indemnify and defend Organizer, landowners, volunteers, service providers, vendors, CK members and officers, officials and sponsors against, and hold harmless from, any and all claims, demands, causes of action, damages, judgments, orders, costs or expenses, including attorney's fees, whether actually incurred or not, which may in any way arise from or be in any way connected with Rider's participation, even if the harm resulted directly or indirectly from the negligence of the Organizer or the Activity, officials, CK members or officers, landowners, volunteers, service providers, vendors or sponsors.

3. In the event Rider is using Rider's own equine, or equine(s) not owned by Rider, Rider warrants said equine(s) shall be free from infection, contagious or transmittable diseases. Organizer reserves the right to refuse access or use of any equine to participate in any Activity if same does not appear to Organizer to be in good health, or is deemed dangerous or undesirable.

4. Rider agrees to assume all liability and responsibility for any accidents, injury or damages sustained or caused by Rider, Rider's helpers, stock or equipment and to expressly assume all risks of harm to Rider and/or horses including harm resulting from the negligence of the Organizer, or the Activity, officials, CK members or officers, landowners, volunteers, service providers, vendors or sponsors.

5. Rider agrees to waive the protection of any applicable statutes in this jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing said release.

6. Riders under the age of 18 years must be accompanied by parent or legal guardian and have obtained signature of parent or legal guardian prior to participation. If I am a parent or guardian of a youth Rider, I consent to the child's participation and agree to all of the above provisions and agree to assume all of the obligations of this Release on the child's behalf.
