**DATE:** April 9<sup>th</sup> (4-Position) & April 10<sup>th</sup> (3-Position), 2016 – Lead, SD

**AUTHORIZATION:** Approved by the SDSSA, NRA

**SPONSORSHIP:** Lead Rifle Club

**LOCATION:** Lead Rifle and Pistol Club Range  
313 W. Main Street – Lead, SD (Basement of Homestake Opera House)

**ELIGIBILITY:** Open to all competitors; NRA membership not required  
SDSSA Membership is required – applications available at match

**REGISTRATION & FEES:** Adults: \$20.00 total - includes NRA and SDSSA match fees.  
Junior (20 Years Old and Under) and Collegiate: \$18 total  
Two-Man Teams are \$4.00 / member (No 4-Man teams this year)  
SDSSA Membership Dues: Annual - \$10; Life - \$100

**RULES:** Current NRA Smallbore Rifle rules will govern:  
Rifle – Rule 3.2 Any Rifle | Sights – 3.7 Any Sights

**TARGETS:** 4-Position will be fired on A-17 with backers  
3-Position will be fired on A/USA-50 with backers

### **3P MATCH SCHEDULE:**

Match #1 – 20 shots prone in 20 minutes  
Match #2 – 20 shots standing in 40 minutes  
Match #3 – 20 shots kneeling in 30 minutes  
Match #4 – SD Individual Aggregate  
Match #5 – Two-Man Team Aggregate

### **4P MATCH SCHEDULE:**

Match #1 – 20 shots prone in 20 minutes  
Match #2 – 20 shots standing in 30 minutes  
Match #3 – 20 shots sitting in 20 minutes  
Match #4 – 20 shots kneeling in 20 minutes  
Match #5 – SD Individual Aggregate  
Match #6 – Two-Man Team Aggregate

**TEAM:** Two-person teams, both members of the same NRA club.

**FIRING SCHEDULE:** Registration begins at 8:00 AM (All Times are Mountain Time)  
Relay 1 – 9:00 AM to 12:00 PM (Both Days)  
Relay 2 – 12:00 PM to 3:00 PM (Both Days)  
Relay 3 as needed. Firing to begin promptly at time indicated.

**CHALLENGES:** The challenge fee is \$1.00 per unsuccessful challenge  
Challenges end 1 hour after scoring is completed.

**AWARDS:** The State Championship will be awarded to a SD resident only, with an appropriate award to a non-resident. A minimum of 70% of entry fees will be returned to competitors. Awards will be provided for first place overall in each position, plus class awards. Sponsor reserves the right to combine classes of fewer than 3 entries.
