

#### THE GYPSY MOTH CATERPILLARS ARE FINALLY GONE

The infestation of gypsy moth caterpillars that plagued our town and the areas around us in May and June is finally over and they now have taken to the air as small white moths. Unfortunately, the eggs have been laid and the cycle will continue.

#### LAKESHORE SEPTIC REPLACEMENT GRANT PROGRAM

Warren County has been identified by New York State (NYS) as being in a priority geographic area where there is a critical need to reduce the impact of sewage effluent from cesspools and septic systems on groundwater and surface water.

Properties located in the priority funding area may be eligible to receive septic system repair or replacement funding. The designation is based on the location's vulnerability to contamination, known water quality problems, and other criteria set by the NYS Department of Environmental Conservation (DEC). All septic system replacements and/or upgrades must be approved by the Warren County Planning Department, be designed by a licensed engineer, and receive all required local permits.

The program can provide up to 50% of the approved costs of eligible septic system projects, with a maximum reimbursement of \$10,000 per project. The maximum of \$10,000 will not be secured without a legitimate itemized estimate. This estimate should list the cost of engineering/design services, time, and material costs. To apply for a grant, complete the grant application HERE and submit it to the county. Read the application carefully and be sure to provide all the requested information. Failing to do so could result in a delay or denial of funding from this program.

It may be to your benefit to hire a licensed engineer or design professional prior to submitting your application. Design costs are eligible for reimbursement at 50% (or a \$3,000 maximum of the total project reimbursement maximum of \$10,000).

Applications will be evaluated in the order that they are received. The application period began on July 6th and will remain open until all funds have been allocated. Costs incurred before April 2, 2021 aren't eligible for reimbursement.

# SEPTIC GRANT PROGRAM, CONTINUED

If your project is selected for a grant, the county will notify you of your award and how much you can expect to be reimbursed. The county will also notify you if your project does not qualify for a grant. If you receive an award letter, you must sign and return the letter to the county. This is a unique opportunity for cooperation between the state, local government, and property owners to address a pressing environmental and public health issue in our community. 

#### PLANNING BOARD - 6/16/2021

Chairperson Dick Frasier, Board Members Judy Gourley, Meg Haskell, and Pam Peterson were present. Dan Belden was absent.

#### McLOUGHLIN (76.8-1-6.2) 252 Silver Bay Road (HS-R)

The applicant is seeking to renovate and expand the square footage of an existing legal non-conforming structure in excess of 25%. A site visit was held. The board made a unanimous negative referral to the ZBA due to the project size and the proximity of the house to the lake and a brook.

#### BROWN (43.13-1-4 23-29) Abenakis Drive (TR-1)

The applicant is seeking to replace two existing legal, non-conforming residential structures with a proposed two-story residence and a patio within the 50-foot shoreline setback. A site visit was held. The board made a unanimous positive referral to the ZBA, with the condition that storm water plans be submitted to the LGPC to obtain a permit.

# GLADING-DILORENZO (12.18-1-5) 9606 Lakeshore Drive (TR-1)

The applicant is proposing to renovate an existing summer camp. Improvements include renovation of the first floor and construction of a second story to increase living space and to move one bedroom of the existing three bedrooms to the second level. A site visit was held. The board made a unanimous positive referral to the ZBA with the conditions that the septic tank size be increased to 1,500 gallons, the septic system grinder be replaced, and storm water plans be submitted to the ZEO to obtain a permit.

# ZONING BOARD OF APPEALS - 6/24/2021

Chairman Robert Goetsch and Board Members Jon Hanna, Maureen Cherubini, Linda Mury, and Ray Snyder were present.

#### BOSI (93.12-1-4) 7955 Lakeshore Drive (TR-1)

At the September 24, 2020 ZBA meeting, the board unanimously approved the applicant's variance to construct a retaining wall along their lakefront ten feet back from the mean high water mark (MHWM). See *The Hague Chronicle* (October 2020) for details. This is an "after the fact" variance for construction of a retaining wall and stairs to the waterfront parcel. This application was previously approved by the ZBA, but reversed by the Adirondack Park Agency. A public hearing was held. The applicant indicated that the retaining wall would result in a significant reduction in storm water runoff. No others spoke

for or against. Specific project details were reviewed. The board unanimously approved the application, which will next go to the APA for review.

#### BROWN (43.13-1-4) 23-29 Abenakis Drive (TR-1)

The applicant is seeking to replace two existing legal, non-conforming residential structures with a proposed two-story residence and a patio within the 50-foot shoreline setback. The two existing structures are within eight feet and 30 feet of the shoreline. The shoreline setback for the proposed new structure would be 25 feet. A public hearing was held. The applicant's architect reviewed modifications to the plans to move the driveway as far west as is reasonably feasible, which would allow for a vehicle to make the turn into the proposed two-car garage, which will include bedrooms and a bathroom on the second floor. The existing carport would be removed. No one spoke for or against. At their June 16, 2021 meeting, the Planning Board voted to make a positive referral to the ZBA, with the condition that storm water plans must be submitted to the Lake George Park Commission to obtain a permit. The application was approved, with conditions that a storm water plan must be approved by the APA and the Hague ZEO prior to being granted a variance.

#### McLOUGHLIN (76.8-1-6.2) 252 Silver Bay Road (HS-R)

The applicant is seeking to renovate and expand the square footage of an existing legal non-conforming structure in excess of 25% (increase of 46%). The project includes an upgraded waste water system and the demolition and reconstruction of an accessory structure with plumbing. The project is subject to Site Plan Review due to its proximity to the MHWM of Lake George. The town board has approved the waste water system for five bedrooms with conditions. A public hearing was held. The applicant's design group indicated that the new residential structure would largely stay within the existing footprint and the proposed setback from the MHWM and the road would increase slightly. The bedrooms would be increased from four to five. The one-and-a-half car garage with additional storage in the back would be replaced with a new garage, which would be rotated to eliminate cars going in and out right onto Silver Bay Road. No one spoke for or against. At their June 16, 2021 meeting, the Planning Board voted to make a negative referral to the ZBA, due to the project size and the proximity of the house to the lake and a brook. The board clarified that the first floor of the garage would have a laundry setup and the new second floor would have a half-bath and yoga room that would be for private use, not for commercial use. They also clarified that the plans showed five full baths, two half-baths and the added bedroom showed multiple bunkbeds capable of sleeping at least six people. Additionally, there would be two laundries, one in each structure. Plans include green roofs and improved storm water runoff. The board expressed concerns about putting so much into such a small space and requested that the applicant consider making modifications to the plans. Any further actions were tabled until the next meeting.

# GLADING-DILORENZO (12.18-1-5) 9606 Lakeshore Drive (TR-1)

The applicant is proposing to renovate an existing summer camp. Improvements include renovation of the first floor, construction of a second story to increase living space, and to move one bedroom of the existing three bedrooms to the second level. A public hearing was held. A family

member of the applicant indicated that there would be no changes in the setbacks and the shared septic system would be certified. No one spoke for or against. Two houses share one septic system. The Planning Board made a positive referral to the ZBA, with the conditions related to the septic tank and storm water runoff. The board unanimously approved, with the conditions that the septic tank be increased from 1,000 gallons to 1,500 gallons and that a storm water plan be submitted to the ZEO prior to granting a permit.

#### LAZARUS (93.19-1-16) 7740 Lake Shore Drive (RC)

At the February 25, 2021 ZBA meeting, the board unanimously approved, with conditions, the site plan review for the installation of a hillside trolley to provide handicap access to the applicant's lakefront property. The trolley is to run alongside an existing staircase and will be within 100 feet of the MHWM, requiring an area variance for a trolley and site plan review. See *The Hague Chronicle* (March 2021) for details. The APA reversed the previously-granted variance due to insufficient information provided to them by the town, requiring a resubmission. The board unanimously approved adding this resubmittal to the July agenda. The applicant is quite eager for the trolley to be installed and provided the board with information about his health condition, along with documents concerning the Fair Housing Act, which he feels should apply to this project. The board agreed to present this information to the town attorney. The contractor prepared packets for the board to present to the APA, which he feels will help provide the needed details for the approval process.

# PLANNING BOARD - 7/1/2021

Deputy Chairperson Pam Peterson, Board Members Dan Belden, Judy Gourley, and Meg Haskell were present. Chairperson Dick Frasier was absent.

#### LEUDDEKE (10-1-25.1) 164 New Hague Road OCII

The applicant is seeking to subdivide a 60.98-acre parcel into two lots of 52.98 acres and eight acres. A public hearing has been scheduled for the August 5th Planning Board Meeting.

#### DROPPO (26.18-1-9) 9221 Lakeshore Drive (formerly Ruah)

The applicant is seeking to build a one-car garage with an office and a half-bath on the second floor, adding 600 sq. ft of impervious surface. A public hearing was held. Project representatives reviewed details on storm water management plans and blasting mitigation (such as by using expanding grout instead of explosives). Neighbors expressed concerns about storm water runoff and blasting. The application was unanimously approved with the conditions that storm water runoff be monitored, blasting, if necessary, will occur between September and May, affected neighbors will be notified, and the town can inspect the accessory structure during the two-year permit process with a 48-hour notice.

#### BROWN (43.13-1-4 23-29) Abenakis Drive (TR-1)

The applicant is seeking to remove two existing legal non-conforming primary structures within 50 feet of the MHWM and build one primary structure along with constructing a two-story garage with full bath and sleeping quarters on the second story. An existing carport would be removed. See Zoning Board of Appeals (6-24-21) on page 4 for details. A public hearing was held with no one speaking for or against. The board noted that the lot is large enough to have four structures. The application was unanimously approved, with the condition that the town can inspect the accessory structure during the two-year permit process, with a 48-hour notice.

#### **TOWN BOARD - 7/13/2021**

Supervisor Edna Frasier, Deputy Supervisor Steve Ramant, and Councilman Jack Bast were present in the room, while Councilman Josh Patchett joined in via Zoom. Councilman Martin Fitzgerald was absent.

A moment of silence was held for Bernard Clifton, Jr., Kenneth Engler, and Eleanor Butler Crossman.

During privilege of the floor, Pam Peterson asked about campsites that are on private properties. Frasier noted that the ZEO Michael Auerbach will look into it.

Peter Maltese mentioned that parking spaces at the beach designated for residents are sometimes not available because they are taken by visitors. Ramant said he would address the issue with the launch attendants.

Pat Hintze commented on the parking at the beach and on recycling and staffing at the Hague Transfer Station. Ramant revealed there will be a change of protocol at the transfer station. There will be a public meeting in August to discuss the changes. He and the supervisor noted that if the plan doesn't work, the town might shut down the transfer station.

Tim Fiallo gave the highway report and noted that there are some roads that have been damaged by weather and will need repair. Residents who will be affected by the repairs will be notified.

Ramant reported that the fireworks had to be canceled twice and will now be held on August 14, 2021. He also gave an update on the Knotweed Project.

Bast said that additional training will be given to the new ZEO and thanked Cathy Clark for her help in supporting the office.

The board passed the following resolutions to:

- revise the sewer warrant
- approve the EDU appeals form
- appoint Tim Fiallo as the Chief Audio-Visual Technician, including as ZOOM coordinator
- accept Janet Hanna's resignation as deputy town clerk
- appoint Megan Elizabeth Clonan as town clerk until the end of the year. She will work one day a week before joining full-time in September.

Frasier announced that the town will receive over \$68,000 in coronavirus payments over a two-year period. The money can be spent on the wastewater treatment plant.



#### WATER QUALITY MATTERS

So, I get this letter the other day - plain white envelope and one sheet of white paper inside. Almost threw it out with the other junk mail, but then I realized **THIS IS BIG NEWS!** It was from

the Warren County Department of Planning and Community Development and announced a new program to help fund septic system upgrades. It doesn't apply to me since I am lucky enough to be tied in to the Town of Hague waste water treatment system. But, for others in town, this may be just what you have been waiting for. Some of the key points are summarized below.

"Warren County has been identified by New York State as being in a priority geographic area where there is a critical need to reduce the impact of sewage effluent from cesspools and septic systems on groundwater and surface water. Properties located in the priority funding area may be eligible to receive septic system repair or replacement funding." The letter did not mention Lake George or its tributaries specifically, but on the website (referenced below) eligible properties include those in Warren County within 250' of Lake George.

"The program can provide up to 50% of the eligible costs of eligible septic system projects, with a maximum reimbursement of \$10,000 per project. To apply for a grant, please complete the attached grant application (not attached to my letter, but available on the website) and submit it to the county." The application would contain the cost estimate for the proposed work including the cost for engineering/design services.

"Applications will be evaluated in the order that they are received. The application period begins on July 6th and will remain open until all funds have been allocated. Costs incurred before April 2, 2021 are not eligible for reimbursement under the terms of this grant program." There was no mention of how much money is available through the program, so it will be important to get your application in early for best results in obtaining a grant.

"The county encourages you to apply to this program. This is a unique opportunity for cooperation between the state, local government, and property owners, to address a pressing environmental and public health issue in our community, and we hope you will take advantage of it."

#### TIME AT THE BEACH

In the Spring of 1981, Daniel D. Belden, by deputation, presented a group of rough hewn boys, ages 13 to 15, to the Hague Town Board (which sat in the old hall adjacent to the beautiful river-rock-constructed Baptist Church) with a simple plea: "These boys want to play baseball." And so, it began - The Hague Babe Ruth Baseball Team.

A more inauspicious beginning is hard to imagine.

Confusion reigned and misnomers were the norm. Our pitcher was "Whitey," the center fielder was "Clyde," Paul was "Ralph," and Craig was "Tony." Our ball field was a sunken plain cut into the woods off Decker Hill Road, which was dubbed "The Beach" to mock a disgusted opponent who labored under the misconception that a baseball field should have grass. Ours was 50% sand, 50% rubble, and 100% occupied by hordes of black flies, mosquitoes, and assorted bees.

Although many people from the town contributed to make the baseball team possible, the man with the vision was our coach, who we all called "Dan." He scoured the North Country to find teams to play, had the town crew help spruce

spiderwebbed Dan's windshield, his explanation was, "He's a good kid. He can hit the ball straight, but he just got confused."

The uniforms were brick red with black letters. Because money was limited, the uniforms featured the names of different sponsors on the back, including The Trout House, RJ Stormer & Son, The Hague Supermarket, and the granddaddy of them all, The Cave. As it turned out, this team of strapping youths with unrefined talent could really play ball and ended up manhandling teams from Chestertown to Indian Lake to Ticonderoga, the constant mayhem and missteps assuaged by Dan's healing gift of laughter.

Life lessons flowed from Dan with regularity and startling syzygy, my favorite being, "When someone hires you to cut the grass, you cut it, not smoke it." In the last game of the season, against the dreaded Crown Point Panthers, their

up The Beach, and rounded up volunteers to forge a team. Dan coached by two rules: everyone on the team got to play and every game was played in good cheer — not that we minded playing roughly from time to time. Practice began with Dan standing at the plate, cigar clenched in his teeth, hitting grounders and pop flies. His coaching style was an interesting mix of baseball fundamentals and practical philosophy, such as "Rudy, when you catch the ball, use your glove not your face." Once, when a player at bat for the first time fouled the ball over the backstop and

chipped in to get Dan a gift I cannot recall, but it was probably a six pack. By default, the duty of benediction fell upon me, which I discharged after summoning all my powers of eloquence: "Thanks Coach from all of us, your team."

Our time at The Beach brought us together, kids of different ages, backgrounds, and abilities. It has been said many times over the years that Dan gave much to the town. In 1981, he gave us, his team, something of ineffable value baseball and the feeling of what it means to belong.

In addition to the outpatient specialty clinics, patients have access to primary and emergency medicine, imaging, laboratory, and physical, speech, and occupational therapy services.
