Resolution No.072114-10 for Casco Senior Services renewal for the language to be put on the ballot for November. The ballot language is-

Shall the previously voted increase of .25 mill in the tax limitation imposed under Article IX, Section 6 of the Michigan constitution on general ad valorem taxes within Casco Township reduced by the required roll back to .25 mill, be renewed at .25 mill (\$0.25 per \$1000.00 of taxable value for real and personal property) for the four year period of 2014 through 2017 inclusive, for the purpose of funding activities or services for older persons, meaning individuals over the age of 60 years in accordance with Public Act 39 of 1976; and shall the Township be authorized to levy such renewal: The estimated revenue the Township will collect if the millage is approved and levied in 2014 is \$49,250.00.

Lu made motion to approve Resolution No. 072114-10. Judy seconded. Roll call vote: Josiah, yes, Allan, yes, Lu, yes, Judy, yes, & Cheri, yes.
