  - (3) Zoning to ST – Storage District proposed Lots 21-43, Block 12, as designated within a bold dash outline on a revised plan of proposed subdivision prepared by Meridan Surveys Ltd. dated July 23, 2009 as shown in “Plan A” attached and forming part of this bylaw.

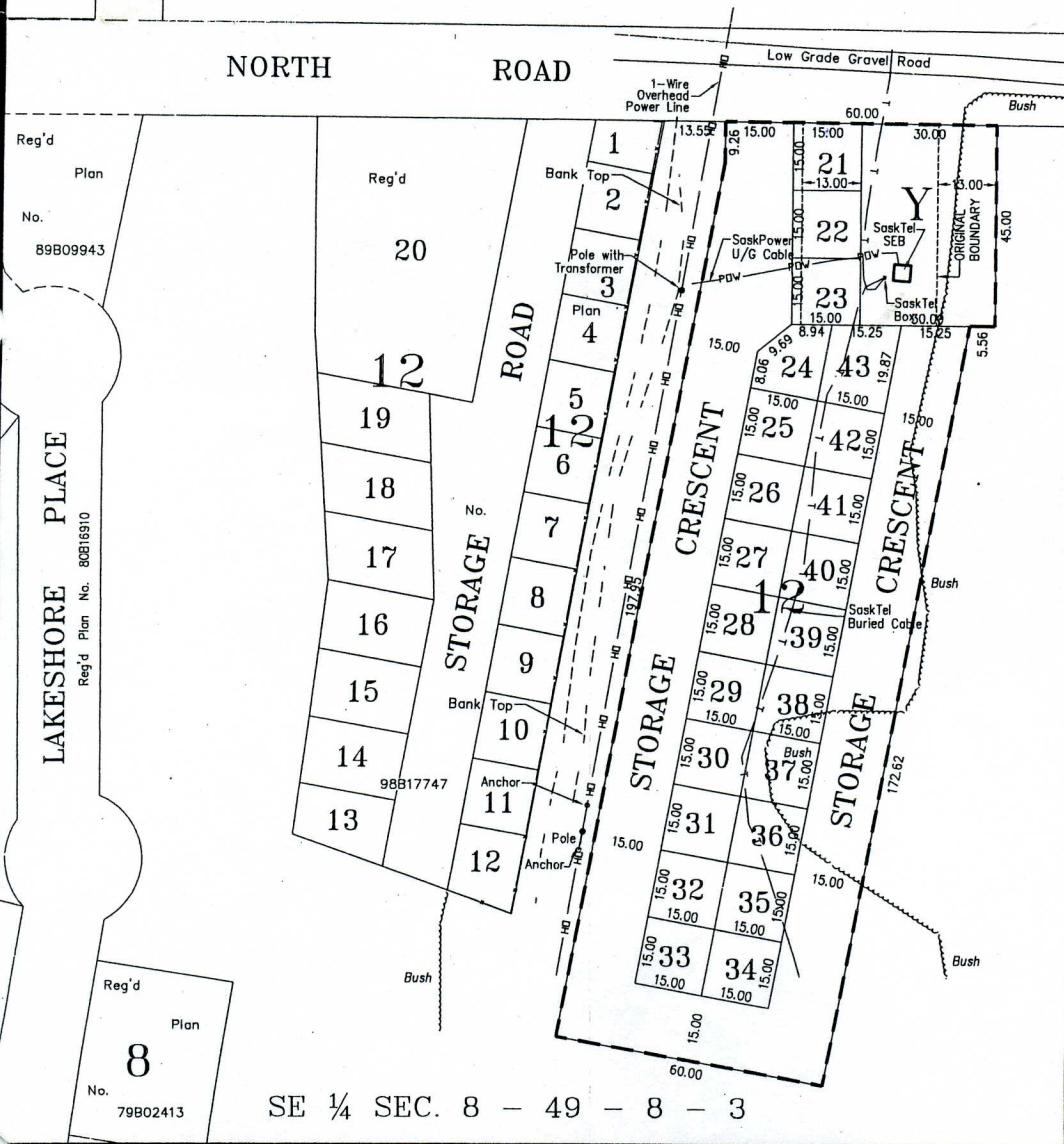
