Qualifications for Intent to be a Candidate and BIO for Board of Directors of the Friends of the Port St. Lucie Botanical Gardens

Candidates should reference Friends of the Port St. Lucie Botanical Gardens By-Laws Article IV, Section 2-B Qualifications of a Director as follows:

Qualifications of a Director. Prior to assuming a seat of the Board, all elected and appointed Directors must have completed a minimum of twenty-five (25) hours of volunteer work for Friends, fifteen (15) hours of which must have been at The Gardens. Any person who is elected as a Director must be twenty-one (21) years of age or older, hold and maintain a current Friends' Membership, have demonstrated an awareness of the purposes and needs of Friends and have committed to actively participate as a Director. Directors shall attend their scheduled meetings, all Friends' events at The Gardens and all Membership events whenever possible. At all times, at least one-third (1/3rd) of the then current Directors shall be residents of the State of Florida and citizens of the United States of America. No paid employee of Friends may serve as a Director. No two (2) members of a family unit (i.e. husband/wife, parent/child, siblings, significant others, etc.) shall serve as Directors at the same time. The Director terms/qualifications contained herein shall not be modified.

Resume/BIO
