

# Pacific Northwest Portuguese Water Dog Club

This is your FINAL confirmation letter for the PNWPWD AKC Agility Trial March 16-18, 2018 at Evergreen Fairgrounds in Monroe, WA. **Trial Information:** Trial statistics and other pertinent information will be posted at [www.k-9sports.com](http://www.k-9sports.com).

**Move-ups:** The deadline to send in your move-up is Monday, March 12, 2018 at 6:00 pm. Move-ups must be submitted in writing (email ok). Day to day move-ups will be accepted and must be done within 45 minutes of the close of the trial each day.

**Height Cards/Measuring:** We will have a VMO available for measuring. All dogs without height cards will have to be measured, including 24" and 24C" dogs. We will have a measuring official available to measure dogs each day near the trial secretary's table.

**Start Time & Running Order:** Check in and measuring time will begin at 8:00am on Fri, 7:00am on Saturday and Sunday. First dog on the line at 9:00am on Fri and 8:00am on Saturday and Sunday. This will be a 2 ring, 2 judge trial. The class running order will be as follows:

**FAST CLASS WALK THRU** We will walk Exc/Master FAST and then Run Exc/Master FAST. Then we will walk Open and Novice FAST and then Run Open and Novice FAST all together by jump height.

**Off Leash Areas:** There are actually no designated off leash areas at AKC trials. In addition, Snohomish County requires all dogs on county property (i.e. the fairgrounds) to be on leash. **And PLEASE pick up after your dogs.**

### **B MATCH**

Thirty minutes after the trial ends on **Saturday**, there will be a B match. A B Match runs exactly like a show, but with no scoring. You may use toys and you can train in the ring. There will be a time limit per run of 90 seconds. The cost is \$5.00 per run. You must fill out an entry form and entries will be taken day of show. The dog does not have to be entered in the show to run in the match.

**Food:** There will be a food vendor at the arena. They have had good food in the past. We will be giving vouchers for food for workers. There are also many fast food places in Monroe near the fairgrounds.

**Photographer:** Gaff Photography will be available for photos at the show.

**Videographer:** Scott Munden of Tripod Visions will be here to video all your runs. They have several formats available including USB, Email, Dropbox, You Tube, and even DVD's. Be sure to visit them at their table to take advantage of their great deals.

**Volunteers:** We appreciate all our volunteer workers. To help make it easier to volunteer: We will split the Exc/Master class by jump height to change out the workers, so no one has to work an excessive amount of time. We also encourage job sharing, where you may work a particular job the first half of the class and someone else works the second have. Workers with ring conflicts may walk with course and run their dog with a different jump height group if necessary. We will accommodate you whenever possible. We'll also have a worker raffle.

**Conflicts:** If you have a legitimate conflict, mark on the gate sheet with a "C" and we will make every effort to accommodate you. Please arrive early so you don't miss your walk thru.

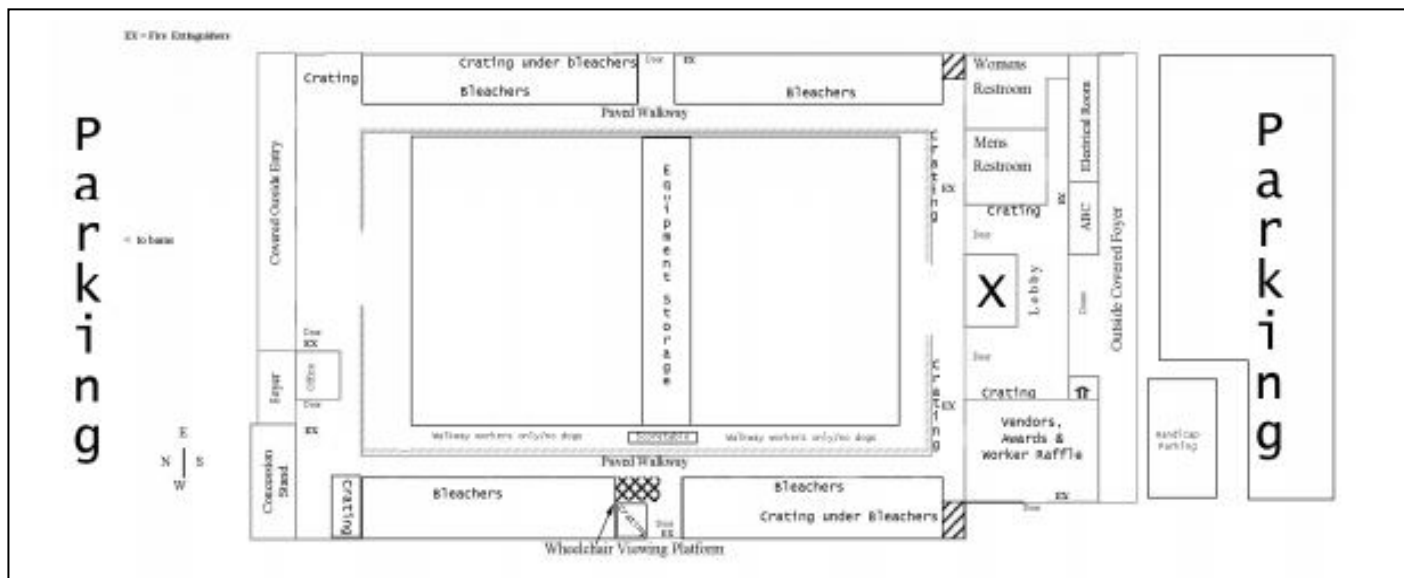
### **Directions to Evergreen Fairgrounds**

**From I-5 North or South.** Take the Highway 2 exit and go East to Monroe. The fairgrounds are on the left side of the road just as you come into town.

**From I-405.** Take the Highway 522 exit and continue north to Monroe. At the end of the road, take the off ramp which will put you out right at the Fairgrounds.

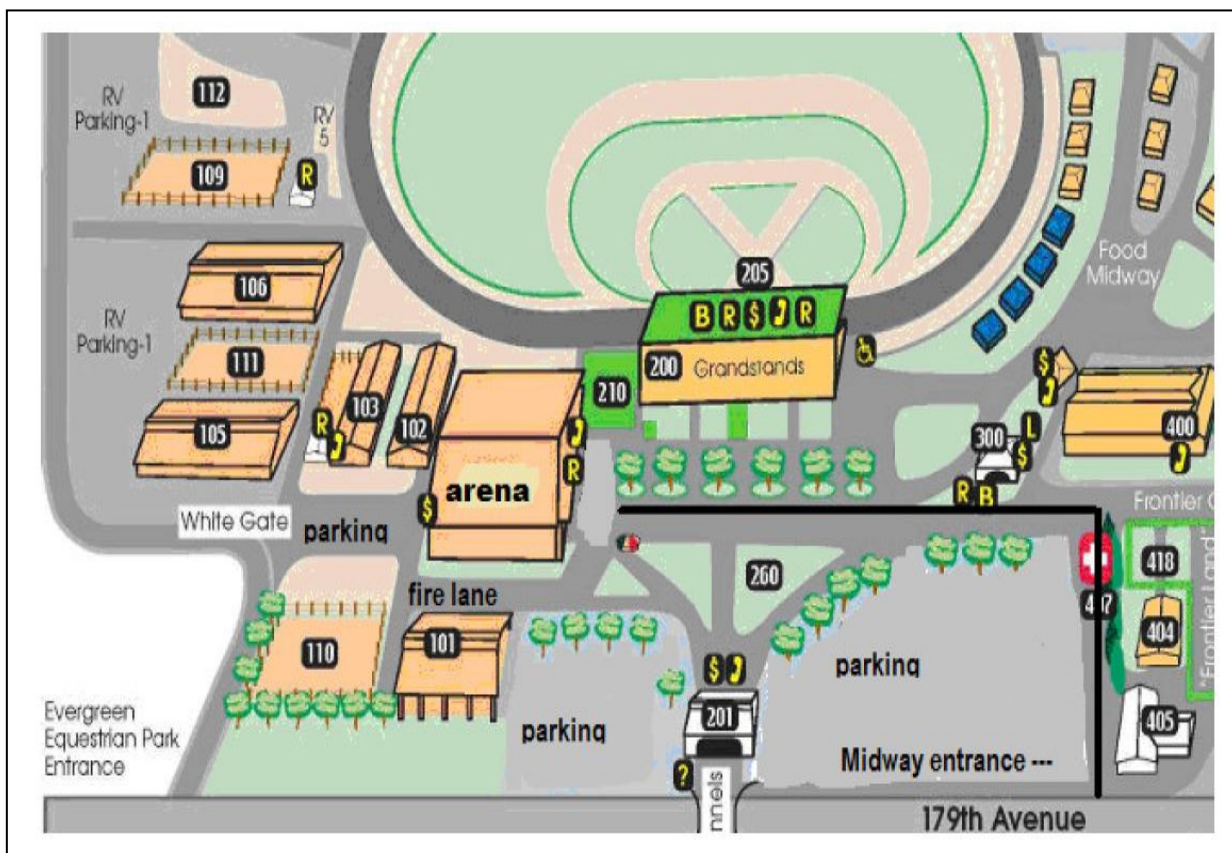
**Crating:** Please crate in designated area only. Be courteous with your space selection and take up no more than necessary. We will have lights under the bleachers for the crating area.

Directions: Leaving the fairgrounds, turn right (West) onto Highway 2. Take the 88<sup>th</sup> St –Snohomish exit and turn left at the end of the ramp. Follow the road around to the right and the clinic is about ½ mile on the left. Saturday hours are 8 am – 4 pm. With an after hours emergency clinic.

**Parking:** There is plenty of parking, but please make sure you park only in the designated areas. DO NOT block fire lanes, the fairgrounds is very strict on this. RVs have priority in the RV area. However, anyone may park in a spot that is designated as a parking spot. There will be some spaces set aside for handicapped parking. You may enter the fairgrounds either through the Equestrian gate or the Midway gate.
