LONG ISLAND COUNCIL OF CHURCHES CHAIRPERSON'S REPORT JUNE 25, 2023

As I finish the final report as your chairperson, I am reminded of all the ways in which we have changed over the recent past. Due to financial difficulties we were forced to close both our Riverhead and Hempstead office; concentrating our resources in the Freeport Food Pantry. We not only had to make commensurate changes in our staff size but also went through a "journey" from the county space to finally ending up, thanks to the generosity of the AHRC in spite of the program to be at our present location. With these changes, we have also changed the structure and bylaws of the Council and made changes in staff job descriptions. With the loss of funding from the county (even though the Council's initial foray many years ago into this ministry of feeding the hungry came about through a request to do this on behalf of Nassau)we have had to pursue other funding resources.

Even as we went through all that change and adversity, there were other realities that remained the same. We continue in a collegial relationship with the Multi-Faith Forum born out of the Council's efforts to foster interfaith religious understanding. Additionally, we have also been in partnership with Jobs with Justice, Abram's Table, the Immigration Alliance, and others with regard to issues of social justice and racial tolerance and fostering care and support for the LGBTQI, immigrant, Muslim, Jewish and other communities that were/are targets of intolerant groups. We continue to be in conversation with the members of interfaith community on how to respond to issues of hunger and intolerance across the Island.

We are thankful for the support in the Long Island Cares and Long Island Harvest organizations — as well as churches and individuals across both counties. A special word of thanks must also go to Rob Hallam and his "crew" of donators, packers, and unpackers of a truckload of food when it was absolutely vital to our ministry. We are grateful for the funding support of the Nassau Bar Association, the Jeanine Heller Foundation, and the many churches and individuals (and in particular the Wantagh Memorial Congregational Church) who have made this ministry possible.

Our two full-time staff, Director of Administration & Operations Deacon Anthony Achong and Pantry & Community Resources Coordinator Yolanda Murray are both to be praised for their hard work ... especially during the COVID outbreak ... making sure that our neediest neighbors could count on our service and care. They continue to provide more than adequate oversight of both the pantry and the community/funding opportunities that are necessary for this program. Thanks also to the volunteer part-time staff much of it through the AHRC program who are equally necessary for the pantry to operate successfully. Not only did these staff people work hard at delivering our food into the hands of our neighbors but, during the pandemic (even with masks, distancing, and shots) put themselves at some level of risk.

Likewise, we want to offer our praise and thanks for our two part-time employees: Rev. Dr. Nancy Schaffer and Rev. Larry Swensen, our two jail chaplains. They likewise continued to deal with issues growing out of both the pandemic and the change in the leadership at the Nassau County Jail. They continue to provide, on our behalf and that of the county, counseling, and worship for the incarcerated population.

Thanks also to the members of our Council – meeting in person and by zoom to see that all the challenges were met and to provide for the financial need of the LICC. their leadership roles. Special thanks to Ron Garner, Claire Deroche, and Mike Mascari and Tom Regan to their respective Committees

LOOKING AHEAD

In the near future our most pressing matter is finding a new home. Our "journey" with AHRC is ending as they seek to use the space that housed the pantry for these last years. Our thanks to Stanfort Perry and his leadership for their generosity and staff support. We are currently in conversation with one church in the Freeport area and are considering others as they become known us. We expect that, though the space may change, our program and capacity will not.

While the Pandemic has been declared over, we have found that the food and other needs have not substantially changed in the moment. Last year our numbers increased to about 700,000 meals from 600,000 the year before. Those on the bottom tier of the employment ladder are still the most likely to remain unemployed. The possibility of SNAP cuts seems to be averted thanks to the state, but other cuts are still possible. The likelihood of the growth of numbers of undocumented immigrants will place further demands. While this may change in the latter part of the year, it may not. We are also faced with the fact that a number of the smaller church-related, weekend pantries that closed during the Pandemic have not yet reopened and some will likely not reopen. Some individuals, churches and funding agencies, believing that the worst is passed, may also cut back on their support. We hope that this will not be true of our funders, but it bears watching.

As we went through our challenging times, we "disappeared from the radar" of many. We were asked at a variety places, "Does the Council still exist?" With the cessation of our publication the "Prelude" the Council has tried in a variety of ways to answer that question. Most recently, we have begun a new website that may reach out, inform, and make requests for support. We may also want to update our clergy directory – though that would require heavy investment of time by our Board.

Longer-term challenge:

As we began our conversations around "new home" searches we looked at a couple of interesting long-term possibilities: developing a multi-site plan for the western part of the Island, an evening hours day for those for whom the daytime hours are difficult, seeking a location near mass transit. Of more significance, to my thinking, is the call to re-establish a feeding ministry and be the Long Island Council if all of our presence and efforts are located on the west end?" This will take thought, developing partnerships, raising funding specifically for that effort and cultivating our local church connections. It should be a priority for the new ministry going forward. Toward this end we might want to dedicate an Annual Special Event.

Finally, I thank you all for your support for me as your chairperson and your confidence in my leadership through these years. As I continue on as the United Methodist representative on the board and serving on one of its committees I look forward to Janice's leadership as the new Chairperson. May we continue to be a witness to our combined ministry to care for those in need and those who need a voice for justice.

Remembering Jesus' admonishment: When you have done it to the one who is in great need (paraphrased) you have done it to me... let us continue with faith and joyous expectation!

LONG ISLAND COUNCIL OF CHURCHES DIRECTOR OF ADMINISTRATION & OPERATIONS REPORT June 25, 2023

Working with the Long Island Council of Churches for the past eight years has been deeply rewarding and has been a wonderful challenge heeding to its Holy Vocation and aspiring to the same vision of Jesus Christ by feeding, clothing, welcoming and uplifting those most vulnerable. Each week brings new opportunities to help as we continue *serving our Neighbors in Need* and by continuing the mission of working with diverse Christians to work together to help Christians and non-Christians to understand one another better.

During this past year, the LICC had to continue with considerable changes in the way we serve as we had to continue to endure the COVID-19 Pandemic alongside our *Neighbors*. This has been an incredible challenge as our volunteers and Work Experience Program (WEP) staff have been cut in half due to the pandemic for safety precautions. However, we have managed to stay open the entire time with special thanks to volunteer Jeanne Oates, Yadelin Martinez, Dianne Garcia, Kharizma Young, Amari Porter, Amiyah Williams, and WEP workers Amirah Aalaan, Maurice Ashley, and Sky Ogle, We are grateful that they choose to stay and help us to keep our doors open.

With the help of our invaluable staff, we had to use that time wisely which allowed us to be able to feed more people in the Freeport Emergency Food Center (Food & Services Boutique). As of May of 2023, we have fed 28,363 individuals 255,267 meals which has higher than 2022's numbers as compared to all of 2022 in which we fed 63,223 individuals 569,007 meals. In addition, in 2022 and part of 2023 we distributed hundreds of Thanksgivings and Christmas baskets, distributed thousands of household items, and helped people with rent and mortgage assistance, transportation, and other problems.

In our effort to continue to safeguard the dignity and safety of every one of our *Neighbors*, we had to switch from a "food choice" modality to pre-picked cart with a wide variety of food items, which at times includes fresh produce and bakery items, as well as household items and clothing. We kept our *Neighbors* as safe as we could offering curbside service in which we were able to continue to provide an atmosphere that was "welcome and warm," eliminating the language "intake process" with instead a "welcome reception."

The support of every one of you, our gracious donors, the LICC Administrative Board, support of the LICC staff, AHRC Nassau, is why **WE** are all *Neighbors*, *serving our Neighbors in Need*.

I thank you so very much for your dedication, commitment, and continuing support.


FREEPORT EMERGENCY FOOD CENTER REPORT

PERSONNEL COMMITTEE REPORT June 25, 2023

The first six months of 2023 have witnessed a continuing high demand for pantry services. Our two full-time staff members, Anthony Achong, Director of Administration and Operations and Yolanda Murray, Pantry and Community Resources Coordinator, have worked diligently as they have throughout the pandemic to serve those seeking our support.

As has been the practice pf the personnel committee in recent years, personnel committee members, Reverend Erik Rasmussen, and Michael Mascari, conducted annual review sessions with the staff in late spring. This year, the focus was on the planning that will be required to facilitate a smooth transition to a new facility. Both Anthony and Yolanda are committed to making a successful move. They also dedicated themselves to maintaining the services on which so many families have come to depend. Although she has made no specific plans, Yolanda Murray indicated that she is giving thought to retiring in the next few years.

The personnel committee also worked with the Board to provide a retirement benefit for the Director of Administration and Operations. Such a contribution would be made annually, contingent upon funds being available within the Council's budget.

As the Council undertakes new challenges, it is fortunate to have such experienced and devoted staff. This year marks Anthony's 8 years working for the Council and Yolanda's 19 years.

LONG ISLAND COUNCIL OF CHURCHES PUBLIC ISSUES COMMITTEE REPORT June 25, 2023

Activities of Public Issues Committee from January 2023-June 2023

Committee Members: Claire Deroche, Chair; Mary Dewar; Luis Valenzuela; Ron Garner; Erik Rasmussen; and Jack King.

The Public Issues Committee presented a report of activities as of October 2022 at the 2022 Annual Meeting. Therefore, this report covers January 2023 – June 2023. During this time the PIC monitored the following issue areas:

January 2023

The Committee voted to sign a letter in support of the passage of the NYS Equal Rights Amendment. The Committee also voted to encourage the LICC Board to also sign on.

The Committee decided to promote the Fair Pay for Home Care Act and provide information so that LICC members could also support the Act.

In the area of Health Care, the Committee promoted a webinar sponsored by the Physicians for a National Health Program. "Building the Local and National Movement for Healthcare for All" which was presented on Tuesday, January 24, 7:30-9:00 PM via Zoom.

Luis Valenzuela kept us informed on actions around Title 42. Our reflections on this issue led to the conclusion that only comprehensive immigration will create true justice for immigrants, migrants, refugees, and anyone seeking asylum in this country.

In January campaigns for Criminal Legal Reform were gearing up for the new legislative session. We shared information about The RAPP Campaign (Release Aging People In Prison) and the Communities not Cages Campaign which held advocacy days in Albany.

February 2023

The Committee learned that Fair Pay for Health Care did not make it into the Governor's budget. This meant that advocacy would continue until the end of the session to pass the bill.

The Committee continued to monitor the immigration situation. We learned that humanitarian parole was offered to migrants from several Caribbean and Latin American Countries. In New York State, advocates were in Albany promoting the Unemployment Bridge Program for not only undocumented immigrants but all workers earning under \$56,000 a year who currently cannot access Unemployment Insurance: self-employed and freelance workers; cash workers;

recently incarcerated workers. The committee signed a Long Island faith leaders' letter supporting the Unemployment Bridge Program.

March 2023

Health Care Advocacy during this month included the Campaign to close the Medicaid gap.

Committee member Rev. Ron Garner promoted the Poor People's Campaign statewide faith committee study of the book, *The Gospel for the Working Class*.

In the area of immigration, advocates asked the state legislature to put in the budget funding to represent immigrants in court by passing the Access to Representation Act (S999/A170). We promoted the website, Care for Immigrants, https://care4immigrants.org/ where members could take action.

In the realm of criminal legal reform, the committee shared information on Daniel's Law, legislation that would promote alternative responses to 911 calls from people in crisis.

April 2023

This month we had some good news in the realm of immigration. Occupational Safety and Health Administration (OSHA) is now taking immigrants' complaints about human trafficking, wage theft, and safety violations; immigrants who are victims of those violations can apply to receive a Visa.

There was also good news for detainees wrongly held in solitary: "New York Awards Up to \$53 Million to Detainees Wrongly Held in Solitary: New York City has agreed to pay as much as \$53 million to settle a lawsuit on behalf of thousands of pretrial detainees on Rikers Island and in Manhattan who were wrongfully isolated and held in small cells for up to 23 hours per day, according to documents filed Wednesday in Federal District Court in Manhattan."

However, there was bad news for those currently being held in solitary confinement. The Correctional Association of New York released a 41-page report, documenting "numerous departures" from the letter and spirit of the HALT Solitary Confinement Law. Because of this situation, The New York Civil Liberties Union and Prisoners' Legal Services of New York filed a class action lawsuit in state supreme court against New York State Department of Corrections and Community Supervision (DOCCS) for illegally subjecting people to prolonged solitary confinement in violation of the Humane Alternatives to Long-Term Solitary Confinement Act (HALT), passed in 2021.

June 2023

The Committee signed a faith leaders' letter supporting the right of asylum seekers to enter Nassau and Suffolk Counties and condemning government leaders who are trying to block them from entering Long Island.

Erik Rasmussen shared that he is in conversation with Richard Koubek of AMOS about forming rapid response teams to be ready to address acts of racism on Long Island. The teams may be ready to go in the fall.

The Western Area Steering Committee is currently comprised of Board Member Ms. Jessica Haselkorn, Elder Isoken Irowa (Christ First Hempstead Presbyterian Church), Reverend Moira Ahearne (Presbyterian Churches of Merrick and Freeport) and Board Member Reverend Janice Moore (Community Presbyterian, Malverne).

Our primary focus has been on branding for the Freeport Emergency Food Pantry. We have hired a like-minded digital marketing professional to work on this project. Logo development is being finalized and the website design will begin this summer.

We can continue to be on hand to support Deacon Anthony Achong as strategic advisor.

Easter Sunrise service resumed this year at Jones Beach and was well attended.

I recommend that this committee be disbanded and re-established as an advisory council to the Freeport Emergency Food Pantry
