If you are the first person selected, you will be invited to view the unit to see if you are interested. If you are not interested, we will go to the next person on the list. However, when the next unit becomes available, our list is rerandomized, meaning that you will not receive preference for the next available unit. If you are interested, you will be required to submit all necessary documentation and income verification, as well as meet any credit requirements, to be certified for occupancy. If you are certified as an eligible occupant, you are eligible to move into the unit. If you do not meet all certification criteria, you will be removed from our list and must reapply when, and if, you meet the income requirements.
