John made a motion to send letters to abutters of the town-owned property, Map 13 lot 113 on Eastman loop to see if there was any interest in purchasing the property. Second by Ed. All in favor.

Next week the Board will work on deciding which Town-owned properties will go up for auction.

The Board discussed moving the Police Department to the Fire Station. John will write a letter to the Fire Chief.
