COVID-19

All precautions, as advised by the State of Illinois, will be in effect and enforceable by the host clubs. Non-compliance may result in a forfeit of entry.

Special Notice

Illinois requires all Hunting Test and Field Trial participants to carry a valid hunting license and habitat stamp. This included gunners, handlers, and scouts. The law does not apply to non-residents who wish to participate in these events. The sponsoring club will obtain a waiver of license for non-resident participants.

Eligibility and Risk

Open to all pointing breeds in good standing with the AKC. AKC-registered dogs must be six months of age or older on the event date. ILP/PAL dogs are eligible to participate. Bitches in season are not allowed and are not allowed on the grounds. Dogs are ineligible to enter a test if the test's Judge or Judge's family member has owned, sold, leased, boarded, trained, or handled the dog within one year of the test date. Owners or handlers entering a test do so at their own risk and agree to assume responsibility for any damage caused by them or their dogs.
