PRESIDENT'S REPORT

My Friends,

We start off this year looking to see what dredging remains and reviewing our plan for paying for it. We are limited in how fast and how much silt we remove by government requirements for proper disposal. We cannot dig faster than we can dispose. We also have Hickory Bridge repairs to accomplish and maintenance on our dam to make sure any empty spots in the concrete wall are filled and our runoff basin is properly functioning. These major projects require planning, time and effort by multiple levels of inspectors, contractors and our staff. Our General Manager went over a long list of projects at the last Board meeting he has planned for this year and we are grateful for such a talented staff to get so much done.

Keeping our septic systems checked and operating properly is critical to the health of our Lake & community. There is a program, sponsored by The Thomas Jefferson Soil and Conservation District to assist folks who need help covering the cost of inspection, pumping, and perhaps replacement if appropriate with details at the BRS office.

In continuing cost cutting moves our General Manager has negotiated a new Fourth of July fireworks contractor to handle all aspects of transport, setup, igniting and removal for thousands of dollars less than before. This is our largest social event of the year and many volunteers help bring a small town flavor to our day long family events and fireworks display. We look forward to a new and exciting Fourth of July celebration this year and encourage you to plan on attending. The Board is also

looking at reducing postage costs by providing the Shore Line online and only mailing copies to those who affirmatively request that more expensive method of delivery. This means you need to notify the office of your email address to receive emailed alerts as well as your Shore Line copy. Hard copies will still be available for pickup at the office, but our goal is to transition to a mostly paperless delivery of communications to reduce costs and improve the flow of information. Don't be left out. Provide your email to the office to stay current on the latest developments.

Remember that our trash company is not required to pick up bags or items left next to trash cans on collection day. While they may, on occasion, help you out, we are supposed to place trash materials in sealed bags inside our trash containers. Leaving furniture and stacked bags next to your trash container is unsightly, may attract wildlife, and will not be picked up. We also need to get our empty trash cans back up to our houses so they do not blow around the street and create a driving hazard.

We emailed a survey to members seeking your thoughts on how we may improve our community and what you consider to be important priorities in the year ahead, The Board tracks those results and we use your survey projections on helping us focus on shared community goals through the year. Please take a few minutes and share your thoughts so we may hear from as many folks as we can. This is YOUR community and we are asking for YOUR ideas and comments to grow together.

Virginia Boating Safety Class

Section II, Policies, Rules, and Registration; D. Boats requires that all Motorboat Operators complete this class or an equivalent and present proof of Compliance to receive their boating

registration this year, (2017). This policy has been phased in since 2011 and effective July 1, 2016 all operators of motor boats regardless of age, shall meet the requirements. If you have completed this class in another State and have that certificate of completion, it will meet the BRS requirements. An



operator under direct supervision of an individual who has met this requirement is not required to take this class.

The Office cannot issue 2017 registration/decals unless the above requirements are met and a copy of completion is submitted for your file.

SCHOOL BUS STOP PROBLEMS



The Office continues to receive complaints regarding the school bus stop on South Lakeshore Drive. A few parents are continuing to park on South Lakeshore Drive and Beach Road which is not

permitted and crowding the bus as it enters and departs the area. Parents are parking within the entry and exit areas of the bus stop creating additional safety concerns. A few parents are driving out of the area while the flashing lights are activated and the children are walking to their parents. This is a violation of State Law. This occurs almost every day involving the Elementary School Bus. The Sheriff's Department is working in conjunction with the Association to resolve this problem. WE appreciate the parents that are helping us resolve these problems as well. Safety of the children is the single priority so please help!

Compliance Committee Report

Septic System Inspection

All members are required to have standard septic systems inspected every five years by a certified septic company. Alternative pumping systems must be inspected and or pumped every year. Please submit your certification to the office. This is not only a BRS requirement but a requirement from the Commonwealth of Virginia enforced by all county health departments. The BRS office notifies each member at the beginning of the year when your system is due for inspection. You have until December 31 to comply. Members that do not comply may be fined \$10 per day for 90 days. Our Committee recently took this action on three members and this information may be posted in the Shore Line by name and Street Address. There are no exceptions. This rule is to ensure the health of our lake and the health of our water supply. Thank you for keeping Blue Ridge Shores a healthy community for all.

POSTED SPEED LIMITS

The Association Office receives complaints routinely for people driving throughout the Community and exceeding the posted speed limits. The Louisa County Sheriff's Department has been most helpful in their attempts to resolve this problem. They have jurisdiction to write summons for speeding or reckless driving on Association Roads and the results go into Louisa County General District Court and if found guilty those results will be posted with DMV and appear on your Virginia Driver's License Records.

The Sheriff's Department has assured us of enhanced efforts to resolve these problems and will be placing Deputies in the areas of complaint. Please be considerate of yourself and others as it relates to the potential consequences of traveling too fast within the Community.

REMINDER: All Members and Registered Renters are responsible for their guests and their actions.

During the very frigid temperatures last winter we had several instances of pipes

If You Suspect a Frozen Pipe

The cold weather season is upon us bringing about the possibility of frozen pipes. If you open a faucet and no water comes out, don't take any chances. If you suspect a frozen pipe call a plumber. If a water pipe bursts, turn off the water at the main line cut-off valve and the house cut-off valve; leave the faucet(s) open until repairs are completed. Don't try to thaw a pipe with an open flame as this will damage the pipe and may even start a fire.

Trash Removal

Please move your container from the normal storage place in order for the driver to realize it requires service.

URGENT Let's Be Proactive and Stop The Spread Of Hydrilla

About 25 years ago, Lake Louisa was invaded by an aquatic grass called Hydrilla. This is a plant originally imported into the U.S. to be used in aquariums and sometimes called "water kudzu" because it grows so fast. Hydrilla became so thick in the lake that many of the coves were unsuitable for swimming or wading and it even became difficult to operate boats in these areas because the hydrilla fouled the propellers so badly. By introducing a type of grass carp that feeds on hydrilla and other underwater vegetation (not the common carp found in most rivers, lakes and ponds) hydrilla has been eliminated from the lake.

While we have not seen any evidence that hydrilla is making a comeback in Lake Louisa, it is definitely making a comeback in Lake Anna and other rivers and lakes in Virginia. We do not want to have a recurrence in our lake. Hydrilla is easily spread by introducing even very small pieces into the water.

Therefore, we are asking that if you use your boat in other lakes or rivers please do the following before putting your boat in our lake.

- 1. Carefully check the boat, motor, propeller, and trailer;
- 2. Remove all plant material;
- 3. Thoroughly rinse off the boat and trailer before launching in Lake Louisa; and
- 4. Do not allow the runoff from this to enter the lake.

More information can be found by doing a simple internet search on "hydrilla in Virginia waters". Your cooperation will help protect the health of our lake.

The Thomas Jefferson Soil & Water Conservation District is currently offering a cost-share assistance

program for septic pump-outs or replacement of failing systems to the residents of Louisa County. All residents are eligible to receive up to \$150.00 towards the cost of a septic system pump out. Reimbursement rates for repairs or full replacement of septic systems range from 50-75% and are based on financial need. The TJSWCD along

with the Department of Environmental Quality has developed this cost-sharing program in order to address residential pollutants and to increase septic system awareness.

General Manager's Report

We have enjoyed working with the membership during the past year and look forward to working with the members' needs in 2017. We are extremely pleased with the fourth consecutive year of less than 5% delinquency report for assessment collections. Our collections % in 2016 was 95.6% and all but three members honored their commitments for the partial payment agreements. This also included collecting approximately \$20,498.08 in previous year's delinquencies. Appropriate liens and judgments were filed on those members that did not pay and they were declared to be MNIGS. Please review your 2017 invoice for accuracy and contact us immediately for any necessary corrections. I urge those that wish to sign up for a **Partial Payment Agreement** to do that early, in order to avoid higher monthly payments.

Please be careful in the morning and afternoons where school children are loading/unloading from the buses and walking to or from home. Just a gentle remind to all that the speed limit throughout the community, **is 25 MPH**. When the school bus has red lights on, vehicles are to remain stopped until those are turned off!

Remember nothing can be placed in the Lake including leaves without Board permission.

When you have building materials, furniture, or fuel delivered, your septic system serviced, or perhaps a moving type vehicle come to your home, please remember the gross vehicle weight cannot exceed five tons on the dam/spillway area or twenty-five tons on the Hickory Creek Bridge. It is imperative that material or service delivery adhere to those weight limits and adjust their entry into the Community according to their destination and be provided with that type of information. RU has winterization tips in the office, should you need guidance. It is a good idea to turn off the valve on the water meter in addition to the inside valve if you close the house for the winter. Ridge Utilities is very pleased to announce that all required 2016 VDH testing of the water was completed with a 100% passing of those requirements. Occasionally we have a leak in one of the mains and when you observe that you do not have water, please turn the electrical breaker off to your water heater. This prevents possible damage to the heating elements. If you notice a decrease in water pressure or availability, you may have a leak. Check the water meter and if the usage dial is spinning without normal usage there is a leak. This past quarter six members experienced huge leaks. Locating these early will prevent huge water bills!

Should you witness any activity that appears unlawful contact the Sheriff's Department immediately. Your identity will not be disclosed by them. The Sheriff's Department is currently assisting by monitoring the speed of vehicles on the roadways and activities during the school bus stop related activivites. This also includes stray dogs. Their nonemergency # is 967-1234.

The BRPOA/RU employees are very diligent about their responsibilities and equally proud of the work they do for both corporations. They are multi-talented; possess a tremendous amount of corporate knowledge, and strive to make Blue Ridge Shores a better place to live. We work together to resolve problems/issues and their energy and dedication levels, pleases me very much!
