- Belt press was operated and adjusted by Jim and Ron for more efficiency when pressing sludge, due to the fact; the new spray nozzles were installed.
- Monthly eDMRs were completed and submitted to the DEP by Jim, Ron and Brian.
- NPDES draft permit was received and public notification was posted at the CMSA Offices.
- Dissolved Oxygen monitoring and limits were added to the NPDES permit, total Iron, Manganese, Aluminum, Phosphorus and Nitrogen will need to be sampled and reported a least once a year. Sampling every day of the week for all other required elements.
- Sewer Service to the Miller Property near the intersections of Jones Street and

Zoskey Road, approximately seven (7) new customers added.
