

ORDINANCE NO. 0-2018-06

AN ORDINANCE OF THE CITY OF CISCO, TEXAS AMENDING SECTION 10-19 "RATES" OF THE CITY'S CODE OF ORDINANCES ESTABLISHING SANITATION RATES; AND ESTABLISHING AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY CISCO, TEXAS:

Section 1: That Section 10-19 "Rates" of the City's Code of Ordinance be amended to read as follow:

(a) The monthly base charges, not including any tax, for solid waste removal shall be as follows:

(1) Residential:






Section 2: That the effective date of the revised sanitation rate shall be immediately upon passage of this ordinance and shall reflect on the next monthly billing statement.
