City Council Minutes

April 1<sup>st</sup>, 2019

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, Ron Doll and Elmer Boecker were present.

On a motion by Ron Doll, seconded by Elmer Boecker and carried the minutes from March 4<sup>th</sup>, 2019 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of two medicals calls last month. Allen submitted bills that needs to be paid to Ridgewater College for \$1,200 (\$600 each-two fire members completed their Initial First Responder training). Reminder to residents that city burning permits will be required, please contact Fire Chief Allen Fiedler. Allen would like the Council to think about building structure for the rescue truck. Allen will talk with Worms lumber for ideas.

Ann Piotrowski brought up to use the City Hall parking lot to gather for a celebration for a June event. Council will discuss and will be talked about at the May meeting, Jaycees is unsure at this time on location, space and activities.

Building Permits for Worms Lumber and Paul Welle, on a motion by Pat Nathe, seconded by Elmer Boecker the above building permits were approved.

On a motion by Ron Doll, seconded by Shawn Duevel carried the annual renewal of a 3.2 liquor licenses for New Munich Baseball was approved.

On a motion by Elmer Boecker, seconded by Ron Doll and carried the Application agreement from Country Club lawn service for \$324.00 was approved.

On a motion by Shawn Duevel, seconded by Ron Doll carried and approved Bryan Kasten to be appointed a Planning and Zoning Member.

The City Clerk reminded everyone of the Board of Appeals and Equalization meeting will be April 4, 2019 from 6:30-7:00 at City Hall.

We have a past resident that has an outstanding balance, we will be sending that individual to collections, several notices have been sent to individual. We also have a

few past due utility accounts, these individuals will be notified again and if past due is not paid, we will look at collections next month.

We had a complaint from a resident on Liberty St, a letter will be sent to the resident regarding couch on property as well as dogs on the loose. If more problem, resident is to notify the Sheriffs department.

The City has 10 lots in town, selling price will be \$20,000 with water and sewer hook up on a motion by Ron Doll, seconded by Elmer Boecker carried the decision of the selling price. If anyone is interested, please call City Hall.
