# MINUTES OF PUBLIC BOARD MEETING HELD AT THE BLUE RIDGE FIRE STATION SATURDAY JUNE 16<sup>TH</sup>, 2018

- 1. CALL TO ORDER Meeting was called to order at 11:00 AM by acting Chairman Perelli.
