
#### MOUNTAIN MUTUAL WATER COMPANY:

# President Mark Richwine

#### Greetings:

As this year comes to a close, I would like to review a few items of note from this past year.

This year's annual holiday party was a great success due to the involvement of many homeowners and staff. Attendance was high and the food was catered by one of our own (Ken and Karen Poncelow). I would like to thank all of those that helped coordinate the event and decorate the clubhouse for the holiday party.

At the beginning of 2018, we had a number of issues with vandalism in the clubhouse (specifically the bathrooms). With aggressive monitoring, both by the staff, board and association members, the incidents of vandalism have stopped. Let's keep up the diligence in watching and reporting when things do not look as they should.

This year, we have had a number of maintenance projects to include:

We began a project to replace the broken asphalt in front of the building with concrete. The job was nearly complete when the cold weather came earlier than expected. We are waiting on a window in the weather to complete the task including sealing the new slabs (prevent staining) and putting in a drainage channel to keep drainage off of the new pad and steps.

We had damage to the back deck off of the swimming pool emergency exit requiring it to also be replaced. It has been replaced with concrete steps.

During this past year, the association has had an issue come up regarding the historical practice of charging a reduced (secondary lot fee) for those owners of record that own multiple lots (this has been done since the mid 1980's). While the decision to change this practice was within the Board of Director's purview, the question was communicated to the membership for their opinion. We received less than 10% of property owners responding with an opinion. In the October board meeting, which was announced, the topic was discussed with public comment. The decision of the Board was to continue the practice.

Due to term limits, there will be two individuals coming off the Board in July of 2019. These positions will need to be filled. If anyone is interested, please contact the office for additional information.

As a final reminder to all property owners, please take time to review the rules and regulations that govern the association, and contact the office if there are any questions or concerns.

#### **CLUBHOUSE UPDATE:**

The new garage door and opener have been installed.

The concrete work has been completed, but has not been sealed. The trash boxes will remain at the end of the new driveway until the concrete can be sealed, which may be 2 to 3 months. The trash boxes cannot be moved because that section of the concrete needs about six weeks to cure due to the cold.

The Board has approved the purchase of two new furnaces, one water heater, and two electrical panel boxes with new breakers. The old items are all at least 15 years old, and the replacements will all be much more efficient.
