Roberta read the minutes of the meeting of Septem- MINUTES After calling for corrections or additions, the chair declared the minutes approved as read. asked about the letter from the Moab Irrigation, and Dale gave the background on the flows to Moab Irrigation Co. was suggested another grate be put on the diversion to keep the flows open.

Dale reported the money that the MCDA asked for to GOLF COURSE buy the pipe for the golf course irrigation system estimate INTERNAL is approximately \$40,000.00. the estimate for the pipe is IRRIGATION The pipe is in to the golf course (3,150 feet SYSTEM \$18,000.00. left to lay down Spanish Valley Drive, and one interconnect. They are working only on weekends, and three weekends should see the project finished. He will put together the length figure and will get the MCDA's pipe ordered today.

Dale states that Paul Rattle had improved a road RIGHT-OF-WAY on George White's property, (easement given to Kerby, Rattle MATTERS had bought from Kerby). When the project was put down the road, Mr. Rattle had told Dale there was 2' of cobble beneath the roadbed. When the trench was dug, the crew found cobble. D.L. read the letter to him from Paul Rattle regarding his complaints. It was suggested the road be watched, and if the trench settles, to put in more gravel.

The San Juan County people have had some problems KEN'S LAKE at the lake, both law enforcement at the Ken's Lake and The LAW ENFORCEMENT San Juan County Attorney would like to enforce a No Overnight camping rule, an 11:00 P.M.Curfew and a restriction on glass containers. D.L. suggested we write to the San Juan County, asking for more information, and asking for cooperation in turning the area over to Parks & Recreation.
