This indemnity provision shall include all liabilities and losses including, but not limited to, claims of the ENTRANT and/or third parties as may be asserted or made against the NORTHWEST WASHINGTON FAIR ASSOCIATION, directly or indirectly resulting from the sole or concurrent negligence of the NORTHWEST WASHINGTON FAIR ASSOCIATION and/or the ENTRANT. This indemnity provision shall include all losses, expenses, damages, reasonable attorney's fees and court costs as may be incurred by the NORTHWEST WASHINGTON FAIR ASSOCIATION of any kind whatsoever experienced or caused by reason of the exercise by the ENTRANT of any of the rights contained under this agreement. All references to the NORTHWEST WASHINGTON FAIR ASSOCIATION and indemnifications extended to the NORTHWEST WASHINGTON FAIR ASSOCIATION herein shall include the NORTHWEST WASHINGTON FAIR ASSOCIATION itself, all NORTHWEST WASHINGTON FAIR ASSOCIATION agents, employees, officers and directors of the NORTHWEST WASHINGTON FAIR ASSOCIATION as well. If a court of competent jurisdiction rules invalid and/or unenforceable any of the provisions or interpretations of this indemnity clause, each of such provisions or interpretations ruled invalid or unenforceable shall be disregarded, but the remainder of this indemnity provision shall be given full force and effect.

RELEASE AND WAIVER OR LIABILITY AGREEMENT

IN CONSIDERATION of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as including but not limited to the racing surface, pit areas, infield, burn out area, approach area, shut down area, and all walkways, concessions and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, EACH OF THE UNDERSIGNED, for himself/herself, his/her personal representatives, heirs, and next of kin, acknowledges, agrees and represents that He/She has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which He/She enters and with which He/She comes in contact and He/She does further warrant that his entry upon such restricted area or areas and his participation, if any, in the event constitutes an acknowledgement that He/She has inspected such restricted area and that He/She finds and accepts the same as being safe and reasonably suited for the purposes of his/her use, and He/She further agrees and warrants that if, at any time, He/She is in or about restricted areas and He/She feels anything to be unsafe, He/She will immediately advise the officials of such and will leave the restricted areas:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, car owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releases", from all liability to the undersigned, his/her personal representatives, assigns, heirs, and next of kin of any and all loss or damage, and any claims or demands thereof on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, working for, or for any purpose participation in the event;
2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise.
3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY, DEATH OR PROPERTY DAMAGE due to the negligence of releases or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage, EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements, or inducements apart from the foregoing written agreement have been made.
