LOCAL REGENTS

Let me start out by saying yes, these last two newsletters are very close together, but we all know sometimes that "stuff" just happens. First, we had a few delays in getting the last newsletter printed and then when it did get printed your State Regent was so excited it was done – she forgot to send it to all the Regents to send out. This job definitely keeps me humble. It will be a while until you receive the next newsletter, notice that the next deadline is January 15, 2024.

Your State Board attended a State Officer's Conference in Arizona during their heat wave (we certainly were warm enough!). We are anxious to share what we learned with all of you. Some items will be shared in this newsletter and others at our Day of Sisterhood in Wilton, on Saturday, September 30th.

Regent, that position that everyone always seems to be unwilling to take. It really isn't so bad. The first thing you need to remember is that you do not have to do it all – the board (the 5 officers of the Court) and the members of the Court are a TEAM. The board is allowed to have planning meetings, but they are not board meetings where decisions are made for the entire Court. All members must have a voice or vote in the final decisions of plans and finances of the Court.

It is the Regent's responsibility to have at least nine monthly Court meetings each year. The Regent or a delegate of the Regent should check on members that have not been attending meetings, court events, or keeping up with court activities or dues; this in turn may ensure that all members are involved in some aspect of the court.

Regents may share information and ideas for projects, but they do not make motions and they do not make decisions unilaterally. A motion needs to come from the floor. A motion must be made and seconded prior to discussing. Regents do not enter the discussion once the motion is made; if they choose to (continued on page 2)

On the 1st Sunday of August, we celebrated the Feast of the Transfiguration. In the Gospel account for that Sunday, we hear about Jesus appearing in glory with Moses, the great lawgiver of Israel, and with Elijah, the greatest of the prophets, in the presence of three of his beloved apostles – Peter, James, and John.



What is the significance of this mysterious appearance?

Jesus went to the mountain knowing full well what awaited him in Jerusalem – his betrayal, rejection, and crucifixion. (State Regent cont. from front page) enter the discussion, they must relinquish the chair to the Vice Regent to enter the discussion. The Regent does not vote on the motion.

Regents to the best of their abilities should extend common courtesies to national, state, and local officers by returning phone calls, emails, and written correspondences in a timely manner. If you have questions/issues, follow the chain of command. If you are having issues with the person above, you contact the next in line. A member has the right to contact any local, state, or national officer or board member.

These tips for Regents are what were highlighted at our conference. Remember you can always go to the Tools of the Trade under Local Courts for more tips on the role of a Regent and many other tips and guidelines for your Court. The Tools of the Trade is the Handbook for Catholic Daughters and may be found on the National Website.

My hope is that I will see many of you at our Day of Sisterhood in Wilton! Please bring a friend and introduce them to Catholic Daughters.

LOCAL FINANCIAL SECRETARIES By Sue Judd-Dyrness, 2nd Vice State Regent



Dear Sisters in Christ,

I hope you have all had a refreshing and relaxing summer with time spent by family and friends.

We as state officers decided to share officer position information with you in this newsletter instead of at our Sister's Gathering on September 30th. I am going to review the duties of the local Financial Secretary.



As a Financial Secretary you are responsible for receiving and transmitting all court funds. You receive all monies, issue receipts for money received, post receipts in the cash book, making notations for identification of where the money came from. Then you transmit the money to the Treasurer, count the money with treasurer and receive a receipt from the treasurer for the money you transmitted to her and file that receipt.

Another responsibility you have is keeping track of your court's membership. Each member should have a page in the Membership Book with their name, member number, address, and the date they joined Catholic Daughters. When membership changes, you need to send additions and deletions to the state officer and the National Office, so the state and national offices are kept up to date. For State send membership changes to me at 633 Chautauqua Blvd, Valley City, ND 58072 or email me at sjuddcda@gmail.com and for National send to Gertrude@catholicdaughters.org. When making membership changes, make sure you use the correct forms, whether it is a new member application, a renewal, or a transfer, a deletion form, a correction form for address, phone number, and email changes. All these forms are in the Tools of the Trade (Our Procedure Manual) on the national website: www.catholicdaughters.org.

You can reconcile your roster by requesting a roster from the national office to make sure the national's roster is the same as your roster. If it is not, be sure to notify the national office with the changes.

You keep track of dues for your membership also. Send out notices when dues are due or remind them if they haven't been paid. Share with your Regent if there are members who haven't paid, so she can decide what needs to be done.

When your court needs supplies from the National Office you should order them.

If you forget any of your responsibilities, you can always check the Tools of the Trade, under local courts, which have all our procedures on the national website.

Flow of Money

I hope everyone has had a nice summer. As part of the ND State Court, I had the opportunity to attend the CDA State and Territorial Officers' Conference once again, July 20-22. I would like to share some of that information with you.

The flow of Court money involves a "marriage" between two officers' books, the Local Financial Secretary, and the Local Treasurer. It is important to keep an accurate record of all income and expenses. They should make sure that their numbers match in their respective logbooks at the end of each month. It will make it easier when the books are checked for the semi-annual financial review.

The Financial Secretary receives all the funds. She records the income in her logbook before giving the money to the Treasurer. The Treasurer provides a receipt for money received and should keep a separate copy for her files. She records the income in her logbook before depositing the funds as soon as possible. The bank deposit receipt is attached to the copy of the one given to the Financial Secretary. When the Treasurer reconciles the monthly bank statement, she should let the Financial Secretary know if there was any interest received or additional fees charged.

It is recommended that Courts use vouchers to track payment of bills. The Regent receives all bills and starts the voucher for the invoice. She gives the voucher to the Financial Secretary who signs it and documents it in her expense book. She then gives the voucher to the Treasurer who records it before writing the check and having the Regent sign it. The payment is given to the recipient as appropriate. The Treasurer presents a monthly report for the Court summarizing all income and expenses.

If anyone has any questions about the Treasurer's position, please contact me. I can also provide samples of the Treasurer to Secretary receipt form or State Court expense form and voucher. I am happy to help.

Local Court Secretaries

As a Local Court Secretary it is your responsibility to serve as designated by the Tools of the Trade and CDA guidelines.

The most important thing to remember as the Secretary is that one is writing the history of your Court. Minutes should be concise but informative. They are written in the third person and sent to board members, including the Court Chaplain. The corrected and approved copy should be signed, dated, and filed.

The recording secretary shall:

Keep accurate proceedings of all meetings.

Have the following items at every meeting:

Minutes Book

Minutes of previous meeting

Agenda for meeting

Copy of National Bylaws

List of all Committees

Copy of Court's Standing Rules

Reads the bills at the meeting.

Conduct correspondence of Local Court, except as specified under the duties of the Financial Secretary. Perform other such duties as may be designated by the Regent.

Content of the Minutes will include:

- 1. Kind of Meeting;
- 2. Name of assembly, board, etc,;
- 3. Date, Time and Place;
- 4. Roll call of officers;
- 5. The Name of the presider;
- 6. The fact that a quorum is present;
- 7. Approval of previous meeting minutes;
- 8. All motions;
- 9. Name of the maker of motions, but not the one who seconds the motion;
- 10. Elections;
- 11. Any other counted vote;
- 12. Signature of the Secretary.

We provide local spirituality, sharing and activity under the support of a vibrant national organization. Members donate to charities, administer scholarship programs and strive "to be helping hands where there is pain, poverty, sorrow or sickness." They embrace the principle of faith working through love in the promotion of justice, equality and the advancement of human rights and human dignity for all.

National Projects and Charities



National Projects and Charities By Angela Scheett, State Treasurer

At the CDA State and Territorial Officers' Conference,

July 20-22, we learned more about the National Projects and Charities. The CDA National Board monitors each Project and Charity and often has representation on agency Boards or at events.

CDA supports five primary causes nationally, which are the National Projects. They include Habitat for Humanity, Holy Cross Family Ministries, the Labouré Society, the National Center on Sexual Exploitation, and SOAR. Please use the websites listed below to see further information.

Habitat for Humanity (https://www.habitat.org/) builds simple, decent, affordable homes for economically disadvantaged people and their families. Holy Cross Family Ministries (https://www.hcfm.org/) was founded by Father Patrick Peyton, CSC, to encourage family prayer, especially the Rosary. The Labouré Society (https:// rescuevocations.org/about/) is a national Catholic nonprofit organization that encourages vocations to religious communities by erasing the impediment of student loan debt. The National Center on Sexual Exploitation or NCOSE (https://endsexualexploitation.org/) was founded in 1962 by a primarily Catholic group of concerned citizens alarmed about the harms of pornography and other forms of sexual exploitation. It was previously called Morality in Media. SOAR – Support Our Aging Religious (https://soar-usa.org/) was founded in 1986 with \$25,000 seed money from CDA. Their mission is to raise funds to help Catholic religious congregations in the U.S. care for their aging members as well as educate the public and develop a national network.

CDA supports ten additional causes, the National Charities. They include the Apostleship of the Sea, Catholic Extension, Catholic Relief, Disaster Relief, Human Life International, Missionaries of Charity (Mother Theresa), National Shrine of the Immaculate Conception, Pontifical North American College, Tutwiler Clinic, and Covenant House.

The Apostleship of the Sea (https://www.aos-usa.org/) provides spiritual, physical and psychological services to seamen at port locations in the U.S. Catholic Extension (https://www.catholicextension.org/) was founded in 1905 to help Catholics in remote areas lacking churches and resources. Catholic Relief (https://www.crs.org/) was started in 1943 to help people in the poorest parts of the world. It reaches more than 100 countries with food, medical and religious assistance and tries to prevent human trafficking and offer survivor support. Disaster Relief is a CDA fund that requires completion of a specific form. At the request of a State Regent where a disaster occurs, monetary donations are sent to the Bishop of that Diocese for distribution. Human Life International (https:// www.hli.org/) is our newest National Charity, taking the


place of Smile Train. It is a U.S.-based anti-abortion and pro-life organization with associates in over 80 nations. The Missionaries of Charity was founded in 1950 in Calcutta, India, by (Mother) St. Teresa of Calcutta. These sisters are dedicated to serving the poorest of the poor regardless of class or creed. Funds for the National Shrine of the Immaculate Conception (https:// www.nationalshrine.org/) in Washington, DC, are used to help maintain this beautiful basilica. The Pontifical North American College (https://www.pnac.org/) is in Rome, Italy, and prepares American seminarians to serve as priests in the U.S. The Tutwiler Clinic serves the poor in

Covenant House was founded in 1985 to help homeless and runaway kids with food, shelter, and crisis care. The CDA National Board has voted to replace Covenant House as of August 30. Currently, they are still looking for a replacement. All checks sent to the National Office after August 30 for Covenant House will be returned.

the Bayou Country under the direction of Sister/Doctor

Anne Brooks. It is a rural clinic in Tutwiler, Mississippi, providing medical, dental and optometry care to all ages.

Five percent of National dues are set aside for charitable donations. However, donations to the National Projects and Charities go into their own specific funds. A suggested donation of \$20 per year per Court for the National Projects is most appreciated. The National Charities are usually more individual for each Court. They may choose a certain amount to give to each of the Charities or choose to support some but not all for various reasons. When making donations, one check can be written for all. If Courts decide to send one check, the amount for each Project or Charity needs to be specified. To make this easier, the National Board has created a form to be submitted with these donations. It should be on the National website soon. Donations are accepted at any time, but many Courts do this at the end of their fiscal year. To be included in the report for the next National Convention, donations should be submitted by May 31, 2024.

National Education Award Winners from North Dakota


Exciting News

We Walk by Faith and Not by Sight in Farming Every Day By Keaton Sorum, Grade 5, Court St. Elizabeth #170, Minot 2nd Place National Winner, Essay Contest, Division 1
