KIFA is a 501c3 nonprofit partially funded by the Queen Anne's County Government, Mid-Shore Community Foundation, Queen Anne's Arts Council, Maryland State Arts Council, United Way, local businesses, donors, and members.

Small Works and Miniature Open Show

This is a judged show of Small Works (up to 12x12) and Miniature (up to 5x5) works in the following mediums: Oil/Acrylics, Water Media (watercolor & gouache), Graphics (printmaking, drawing), Mixed Media/Collage, and Sculpture. Artists may enter up to four works.

Guidelines: All work must be original, created within the last three years, **not previously shown at KIFA** and must not infringe upon any copyright. Reproductions are not accepted. Sculptures must include their own base or fit on a KIFA pedestal. Sculpture artists must be prepared to assist in placing their work in the gallery.

Maximum size including base is 5" high x 5" wide and deep for Miniatures and 12x12 for Small Works. **2-D works must be dry, suitably framed, wired and ready to hang or come with their own stand to display on a table (we will provide small easels.)** No saw-tooth hangers.

All works on paper under glass, should have no exposed edges. We will accept sealed water media without glass.

KIFA reserves the right to reject works deemed unsuitable. All entered works must remain on display through the end of the show. Reasonable care will be taken to ensure the safety of your artwork.

KIFA is not liable for loss or damage to artwork.

KIFA's commission on all sales is 30%. KIFA reserves the right to use images of the winning artwork for up to eighteen months.

AWARDS will be given for Miniature and Small Works separately.

AWARDS WILL BE GIVEN IN SEPARATE CATEGORIES IN MINIATURE AND IN SMALL WORKS (OIL, ACRYLIC, ETC).
