## Grant Information

To insure conformity with tax laws, the Trustees annually review proposed grants. When a grant has been accepted and shown to be a public benefit, not just solely for the benefit of Clan MacLeod, it will be considered for funding with other acceptable program proposals. Regular reports of activities are provided in the Society's national newsletter.

If a Non-Profit Organization is interested in applying for a Grant from the Foundation, and feels its project and purpose are aligned with the Foundation, we would encourage contacting the Foundation for consideration by sending a request for an application to the address below. As a Charitable Foundation, we cannot accept grant applications from individuals. Only organizations with designated 501(c)(3) status by the Internal Revenue Service are eligible unless prior specific approval for a project has been obtained in writing from the Internal Revenue Service by the grantor foundation.
