Transportation Improvements	Hwy 85, Hwy 98
Reclaimed Water Main 10-mile main to service City of Niceville, lateral to service Eglin AFB, and wastewater treatment plant equipment to produce reclaimed water.	\$9M project, with \$7M funded Design at 40%.
Earthwork Fill Material	County and Hurlburt staff are exploring options to obtain fill material for upcoming work
<u>Shared Commodity Purchases</u> Share a purchasing contract for lime rock. Eglin uses limited amounts and could benefit by joining on the County contract.	Continuing idea development

- Charter Co-Chairs are prepared to sign the new charter upon Advisory Board Approval





## Eglin EUL Survey

- A question, online survey soliciting input from Advisory Group on 2 potential Eglin EULs
  - UF REEF Adjacent EUL
    - 13 acre site
    - Along Lewis Turner Blvd next to UF REEF
  - Walt Spence Pkwy EUL
    - 236 acre site
    - South of Walt Spence Pkwy in Niceville



#### UF REEF Adjacent EUL – Response Summary

- Vast majority of suggested uses included research & development and/or office related uses tied to parcel's proximity to Eglin
- Noted incompatibilities included heavy industry, uses that would have a negative impact on Eglin or the adjacent UF REEF (including uses that are especially noisy) and retail – though two respondents suggested retail would be worth considering




#### Walt Spence Pkwy EUL – Response Summary


- Much wider range of suggested uses including office, industrial, educational (including student housing), retail, research & development and a sports complex (multiple mentions)
- Noted incompatibilities included uses that would negatively impact adjacent residential areas (heavy industry, etc.)
- Also concerns expressed about noise contours (from the EOD School) and Walt Spence Parkway
