

9/24/2018

Deputy Copley investigated a breaking and entering complaint located at 38112 State Route 7. Investigation is ongoing.

Deputy Schuerman responded to a stabbing located in Lebanon. Deputy Schuerman determined there was no foul play. There will be a report done on the matter.
