  - Cash Bond amount 125% of Street Superintendent’s estimated costs to re-pave or repair.
  - Liability insurance must provide at least \$1,000,000.00 of coverage per occurrence.
- F. Provide three copies of survey showing placement of proposed roadway, stamped by licensed Indiana Surveyor
