- If we take individual to court can take a year
- Legal time & Costs involve
 - o Title insurance (\$1500)
 - o Review of title reports (approx. 2 hrs)
 - o Prepare Notices (approx. 2 hrs)
 - o File complaint (45 min)
 - o Recording fees (\$50-\$100)

- Board should make motion and to take steps to foreclosure
- Patrick indicated that if there are any glaring concerns in the Covenants he will let us know since he has to review
