Annexation? Nov 6 Election

Exercise the right to vote. At the end of the November 6 (mid-term) ballot, under "Johnson County Special Election" can be found the following:

Proposition A

Changing Johnson County from Tier 1 county status to Tier 2 county status for purposes of municipal annexation as described by Chapter 43 of the Texas Local Government Code.

How confusing is this? Very!

How important is this? Very! It needs to be understood that a vote **FOR** Prop A is a vote for moving Johnson County to a Tier 2 status. Tier 2 status provides protection against forced annexation without an election. A vote **AGAINST** Prop A allows cities in Johnson County to annex without voter approval.

Cleburne Thoroughfare Plan

This long term plan has a direct impact on NRE. The report is dated 2008 and is still the most current plan. A small update was made in 2017, but that update was only applicable to Ridgeway within the city limits. The plan can be found on the web at http://www.cleburne.net/DocumentCenter/View/107/Master-Thoroughfare-Plan-2008?bidld.

Page 13 depicts a 90' wide road connecting FM 1434 to Nolan River Road in the vicinity of Preakness Ct. From there it proceeds north on Nolan River Rd. to about the Cleburne city limits where it veers off to the east and connects up with US 67 in the vicinity of Keene. This build-out was projected for 2030; however, based on other projected build-out dates, that date does not appear achievable.

Property Set Back CCR Change Fails

Community voting on the possibility of changing the structure setback from the property line from 25' to 15' (without requiring a waiver) was cut off on 1 August. The change was defeated by a vote of 42-yes, 9-no with 49 owners not voting. Not voting was counted as a 'no' vote. The number of 'yes' votes needed to pass was 51.
