Engineering Report: AE2S Engineer Jim Olson discussed the Water Plant upgrades in electrical and plumbing. If there are any major increases in cost, it will be discussed further. The Lead Service Line Replacement Project is moving forward, Rolla is now in 2nd position, up from 8th last month. The cost of this project is estimated around \$52,000.00 for the City of Rolla, as 90% is covered by the State Revolving Fund. Rolla will be receiving COVID funds for \$185,422.00 that could be used for these projects. Discussion was had about the allowable uses of funds.

Public Works Committee:

- 1. Public Works Director Cliff Rush discussed issues at the water treatment plant.
- 2. Snow removal has not been an issue so far this year.

Street Improvement Committee:

- 1. Jim Olson discussed need for Survey to get a clear picture of what needs to happen with street project. Estimated cost for the Survey would be \$87,000.00. Discussion was had regarding direction for street project. *Motion was made to go ahead with the Survey and pay for it using* \$75,000.00 from the Prairie Dog Fund, with the remainder to be paid for by the Snow Removal budget, and COVID funds if needed, motion was made by Rebecca Albert, seconded by Hovi Mitchell. Roll call vote was requested with all present voting yes. Motion Carried.
- 2. Discussion was had regarding current outstanding balance with AE2S, Jim Olson requested that these bills get paid before starting the Survey project. This bill was approved to be paid prior to this meeting.

Motion was made to approve all Committee Reports as presented by Blake Gottbreht, seconded by Kyle Hardy. All voted aye, motion carried.

New Business:

- 1. Brian Kraft with RDO Equipment discussed new loader, lease agreement, and warranty on new equipment. Cliff Rush discussed trade in of 2012 loader. Discussion was had on purchasing a new loader. More information is needed to make this decision. Decision will be tabled until next council meeting.
- 2. Lighting at the Football Field needs repair. Discussion was had about options to fix or replace lighting and funding options. Hovi Mitchell and Blake Gottbrecht are on committee researching options and will report back to council.
- 3. North Dakota Rural Water Systems Association discussed assistance available through North Dakota Rural Water Systems Association available at no charge or minimal charge to the city, including rate studies with utilities, leak detection, supplement to engineering firms, and availability of 24/7 if issues come up.
- 4. Balance sheet was presented to council for the Lead Water Line Replacement Project application to the council. City Auditor Erica McDougall is working with AE2S analyst Abby Ritz and AE2S Engineer Jim Olson to finish application for this project.
