A motion was made and seconded to approve a quit claim deed to David Hansen for property on Cornell Road. The motion carried. We also received correspondence on the bridge that Steve Weber is putting in on his driveway. The La Crosse County Surveyor is working on the description and map of Kammel Coulee Hill. The town board has been made aware of a potential petition to abandon Kammel Coulee Hill. We applied to FEMA for public assistance for the storm damage to the roads in August.

Ken Franzen from Bug Tussel will be applying for a conditional use permit for a tower on the Tony Herold property. He presented a plan and maps to the town board. The board reviewed map and location, recommendation to take the proposal to the county.

We received a second notice of non-compliance for the full value assessment. A motion was made and seconded to approve the three-year contract for the assessor, Mark Garlick of \$24,300 or \$8,100 per year. The motion carried. We also received notice of an appeal #2018-06 from Leo's & Leona's to the board of adjustment. We forwarded a copy of our May approved minutes where it was discussed to Josh at Zoning. We also received the contract from Schmitz Inspections LLC and will discuss the checklist next month. Dan received a request for a zoning permit for James Caulum and he sent out the tracking permit to him.

Our next meeting will be Wednesday, December 12, 2018 at 6 pm. A motion was made and seconded to adjourn the meeting. The meeting was adjourned at 7:05 p.m.
