MINUTES

Due to the COVID-19 Pandemic, all Trustees and visitors attended this meeting via videoconference. After roll call, Chairman Thomsen announced that a quorum was present for the transaction of business. Also in attendance were Village Administrator/Clerk, Carla Ayala; Village Attorney, Michael Lindgren and Tracy Dickherber, Innsbrook Corporation.

NEW BUSINESS:

By roll call vote, Trustee Bowers "Aye", Trustee Dunn "Aye", Trustee Sator Absent, Trustee Thomsen "Aye", Trustee West "Aye". With a 4 "Aye", 0 "No", 0 Abstain vote, motion passed and approved.
