

**MINUTES FOR VILLAGE OF CODY
REGULAR MEETING APRIL 9, 2019 AT 7:00 PM AT COMMUNITY HALL**

The regular meeting was called to order at 7:05 PM by Chairperson Richards who stated the time, place and posting of the Open Meeting Act. Present were Richards, Fish, Williams, and Peterson. Hamilton and Ruggles were also present along with guests Betty Williams and Pat Miller

Agenda: A motion was made by Williams and seconded by Fish to approve the agenda. After discussion all voted in favor; motion passed.

Public Input: The BRAN race will arrive in Cody on Monday, June 3rd. Volunteers are needed to welcome the riders and pass out water bottles at the Community Hall. Contact Pat Miller if interested in helping.

Water rates for churches will be \$27.00 bi-monthly and livestock tanks will be \$30.00 bi-monthly. All voted in favor; motion passed. A motion was made by Fish and seconded by Williams to charge \$125.00/metered hour with driver operation for back hoe services with a minimum of one hour. All voted in favor; motion passed. A motion was made by Fish and seconded by Richards to approve the closer of the downtown street for street dance/ beer garden for Circle C. All voted in favor; motion passed. A motion was made by Fish and seconded by Peterson to approve the valuations for insurance on the Village properties. All voted in favor; motion passed.
