Is authorized, pursuant to investigation, to possess in New Jersey for **CONSERVATION** purposes, the following species:

(1) CORN SNAKE ISSUED IN CONJUNCTION WITH NJ SCIENTIFIC HOLDING PERMIT.

- ❖ This permit is issued subject to inspection of premises and may be revoked at any time for violation.
- ❖ The issuance of this permit shall not be deemed a waiver of any other requirements to be met by the permittee necessitated by provisions of any statute, rule, regulation, ordinance or order of any Federal, State or local agency or agencies.
- ❖ No additional Endangered Species of any kind may be acquired or brought into the State without prior written approval from the Office of Permit Management.
- ❖ Unless prior written approval has been obtained from the Office of Permit Management, the regulated wildlife for which this permit has been granted shall not be liberated in this State.
- ❖ Unless specifically stated, the Endangered Species listed above are the ONLY endangered species as defined by N.J.A.C. 7:25-4.13 that may be possessed by authority of this permit.
- ❖ **THIS PERMIT MUST BE DISPLAYED IN A PROMINENT PLACE.** A copy of this permit must accompany any off-site educational or research activities with regulated wildlife.

(1) RED TAIL HAWK; (2) SCREECH OWL; 0.1 BOX TURTLE; 1.0 BLACK RAT SNAKE;
(1) CORN SNAKE - ISSUED IN CONJUNCTION WITH NJ ENDANGERED SPECIES PERMIT.
ISSUED IN CONJUNCTION WITH U.S. DEPARTMENT OF THE INTERIOR, FISH AND WILDLIFE SERVICE,
MIGRATORY BIRD PERMIT OFFICE LETTER OF AUTHORIZATION DATED MARCH 5, 1998.

NO UNSUPERVISED PUBLIC CONTACT WITH REGULATED SPECIES IS ALLOWED.

- ❖ This permit is issued subject to inspection of premises and may be revoked at any time for violation.
- ❖ The issuance of this permit shall not be deemed a waiver of any other requirements to be met by the permittee necessitated by provisions of any statute, rule, regulation, ordinance or order of any Federal, State or local agency or agencies.
- ❖ **NO POTENTIALLY DANGEROUS REGULATED EXOTIC OR NONGAME SPECIES OF ANY KIND MAY BE ACQUIRED OR BROUGHT INTO THE STATE WITHOUT PRIOR WRITTEN APPROVAL FROM THE OFFICE OF PERMIT MANAGEMENT.**
- ❖ Unless prior written approval has been obtained from the Office of Permit Management, the regulated wildlife for which this permit has been granted shall not be liberated in this State.
- ❖ The possession of Endangered Species as defined by N.J.A.C. 7:25-4.13 requires a separate additional New Jersey Endangered Species Permit.
- ❖ **THIS PERMIT MUST BE DISPLAYED IN A PROMINENT PLACE.** A copy of this permit must accompany any off-site educational or research activities with regulated wildlife.
