V. Special Reports

1. OEMS Report – Director Joseph "Jody" Ratliff

- We are working on getting the online 2023 Protocol Test available.
- We have been working to get a Pilot Program for Treatment in Place. That would treat seizures, diabetes and COPD in place, and we would be able to bill for that. I would like to start working in the protocols for that now.
- Chairman Weller discussed that Mr. Ratliff has submitted a proposal that went to the
 insurance companies, and it has three laid out. I would like to send this to the Protocol
 Committee and get this into protocol format, keep in mind it would be a Pilot Program.

- Another big-ticket item we have been working on is Mental Health, we had a great response from the State Communication meeting and have several people wanting to be a part of this.

Over the last year with EMSAC's help the protocols have been updated more in line with West Virginia rules and more organized. Hope to do the same next year.
