

**AMENDMENT TO THE BY-LAWS
OF THE

Pursuant to the provisions of Article XIII of the By-Laws of the Westhollow Villa Townhomes Association, Inc., the undersigned corporation adopts the following Amendment to its By-Laws which:

1. Provides that the Board of Directors shall determine the time and place for each annual meeting of the members.

The following amendment to the By-Laws of the Westhollow Villa Townhomes Association, Inc. was adopted by the corporation on July 11, 1990.

Article III, Section 2, of the By-Laws is hereby amended so as to read as follows:

Section 2. Annual Meetings.

The annual meeting of the Members shall be held no later than June 30th of each year on a date and at a time selected by the Board of Directors.

The amendment was adopted in the following manner:

The amendment was adopted at a meeting of members held on the 11th day of July, 1990, at which the amendment received at least a majority of the votes of the members holding membership votes of the Association, either in person or represented by proxy.



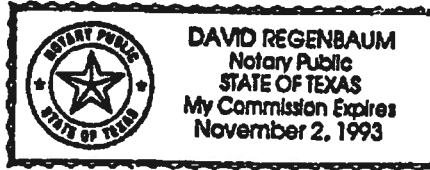

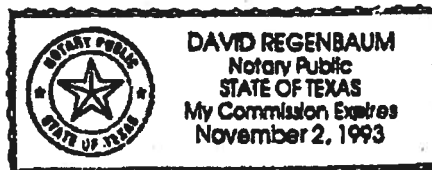
